An Act To Prohibit Consideration of Naloxone Purchases in Life Insurance Underwriting

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 24-A MRSA §2159-E** is enacted to read:

3 **§2159-E. Discrimination against naloxone purchases prohibited in life insurance**

4 Notwithstanding any other provision of law, an insurer authorized to do business in
5 this State may not:

6 **1. Limit coverage.** Limit coverage or refuse to issue or renew coverage of an
7 individual under any life insurance policy due to the fact that the individual has been
8 issued a prescription for naloxone or has purchased naloxone;

9 **2. Determine rate for coverage.** Consider the fact that an individual has been
10 issued a prescription for naloxone or has purchased naloxone in determining the premium
11 rate for coverage of that individual under a life insurance policy; or

12 **3. Otherwise discriminate.** Otherwise discriminate in the offering, issuance,
13 cancellation, amount of coverage, price or any other condition of a life insurance policy
14 based solely and without any additional actuarial justification upon the fact that an
15 individual has been issued a prescription for naloxone or has purchased naloxone.

16 **SUMMARY**

17 This bill prohibits a denial or limitation of coverage or an increase in insurance
18 premiums under a life insurance policy based on the fact that an individual has been
19 issued a prescription for naloxone or has purchased naloxone.
