1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 4 MRSA §8-A, sub-§2**, as amended by PL 2003, c. 20, Pt. T, §2, is further
3 amended to read:

4 **2. Unclaimed property.** To provide, after reasonable notice to interested parties or
5 their attorneys, for the transfer to the Treasurer of State for disposition as unclaimed
6 property in the manner provided by Title 33, ~~sections 1958 and 1959~~ chapter 45 of
7 property in the possession or custody of the courts of this State as a result of civil or
8 criminal litigation.

9 **Sec. 2. 8 MRSA §1032**, as amended by IB 2009, c. 2, §40, is further amended to
10 read:

11 **§1032. Payment of credits by slot machine or casino operator**

12 A slot machine operator or casino operator shall redeem credits for players who earn
13 credits on a slot machine or table game located on the premises of that slot machine
14 facility or casino in accordance with rules adopted by the board. A slot machine operator
15 or casino operator may not redeem a credit slip more than 365 days from the date of
16 issuance. The funds reserved for the payment of such a credit slip or expired unclaimed
17 jackpot must be retained by the slot machine operator or casino operator and treated as
18 gross slot machine income or gross table game income and do not constitute property
19 subject to the requirements of Title 33, chapter 44 45.

§6324. Proceeds of sale

After first deducting the expenses incurred in making the sale, the mortgagee shall disburse the remaining proceeds in accordance with the provisions of the judgment. The mortgagee shall file a report of the sale and the disbursement of the proceeds therefrom with the court and shall mail a copy to the mortgagor at the mortgagor's last known address. This report need not be accepted or approved by the court, provided that the mortgagor or any other party in interest may contest the accounting by motion filed within 30 days of receipt of the report, but any such challenge may be for money only and does not affect the title to the real estate purchased by the highest bidder at the public sale. Any deficiency must be assessed against the mortgagor and an execution must be issued by the court therefor. In the event the mortgagee has been the purchaser at the public sale, any deficiency is limited to the difference between the fair market value of the premises at the time of the public sale, as established by an independent appraisal, and the sum due the mortgagee as established by the court with interest plus the expenses incurred in making the sale. Any surplus must be paid to the mortgagor, the mortgagor's successors, heirs or assigns in the proceeding. If the mortgagor has not appeared personally or by an attorney, the surplus must be paid to the clerk of courts, who shall hold the surplus in escrow for 6 months for the benefit of the mortgagor, the mortgagor's successors, heirs or assigns and, if the surplus remains unclaimed after 6 months, the clerk shall pay the surplus to the Treasurer of State to be credited to the General Fund until it becomes unclaimed under the Uniform Maine Revised Unclaimed Property Act, and report and pay it to the State in accordance with that Act.

11 **MAINE REVISED UNCLAIMED PROPERTY ACT**

12 **SUBCHAPTER 1**

13 **GENERAL PROVISIONS**

14 **§2051. Short title**

15 This chapter may be known and cited as "the Maine Revised Unclaimed Property
16 Act."

17 **§2052. Definitions**

18 As used in this Act, unless the context otherwise indicates, the following terms have
19 the following meanings.

20 **1. Administrator.** "Administrator" means the Treasurer of State.

21 **2. Administrator's agent.** "Administrator's agent" means a person with which the
22 administrator contracts to conduct an examination under subchapter 10 on behalf of the
23 administrator. "Administrator's agent" includes an independent contractor of the person
24 and each individual participating in the examination on behalf of the person or contractor.

25 **3. Apparent owner.** "Apparent owner" means a person whose name appears on the
26 records of a holder as the owner of property held, issued or owing by the holder.

27 **4. Business association.** "Business association" means a corporation, joint stock
28 company, investment company, partnership, unincorporated association, joint venture,
29 limited liability company, business trust, trust company, land bank, safe deposit company,
30 safekeeping depository, financial organization, insurance company, federally chartered
31 entity, utility, sole proprietorship or other business entity, whether or not for profit.

32 **5. Confidential information.** "Confidential information" means records, reports
33 and information that are confidential under section 2212.

- 1 **6. Domicile.** "Domicile" means:
- 2 A. For a corporation, the state of its incorporation;
- 3 B. For a business association, other than a corporation, whose formation requires a
4 filing with a state, the state of its filing;
- 5 C. For a federally chartered entity, the state of its home office; and
- 6 D. For any other holder, the state of its principal place of business.
- 7 **7. Electronic.** "Electronic" means relating to technology having electrical, digital,
8 magnetic, wireless, optical, electromagnetic or similar capabilities.
- 9 **8. E-mail.** "E-mail" means a communication by electronic means that is
10 automatically retained and stored and may be readily accessed or retrieved.
- 11 **9. Financial organization.** "Financial organization" means a savings and loan
12 association, building and loan association, savings bank, industrial bank, bank, banking
13 organization or credit union.
- 14 **10. Gift obligation.** "Gift obligation" means a record evidencing an obligation of a
15 business association arising from a transaction between the business association and a
16 consumer to provide goods or services at a future date for a specified amount shown in
17 the record.
- 18 A. A gift obligation:
- 19 (1) Is a bearer instrument not associated with an account holder or individual;
- 20 (2) May be decreased in value only by redemption for merchandise, goods or
21 services; and
- 22 (3) Unless required by law, may not be redeemed for or converted into money or
23 otherwise monetized.
- 24 B. "Gift obligation" does not include account credits or account balances, including
25 credits or balances funded by gift obligations.
- 26 **11. Holder.** "Holder" means a person obligated to hold property subject to this Act
27 for the account of, or to deliver or pay to, the owner.
- 28 **12. Insurance company.** "Insurance company" means an association, corporation or
29 fraternal or mutual benefit organization, whether or not for profit, engaged in the business
30 of providing life endowments, annuities or insurance, including accident, burial, casualty,
31 credit life, contract performance, dental, disability, fidelity, fire, health, hospitalization,
32 illness, life, malpractice, marine, mortgage, surety, wage protection and workers'
33 compensation insurance.
- 34 **13. Loyalty obligation.** "Loyalty obligation" means a record given without direct
35 monetary consideration under an award, reward, benefit, loyalty, incentive, rebate or
36 promotional program that may be used or redeemed only to obtain goods or services or a
37 discount on goods or services. "Loyalty obligation" does not include:

- 1 A. A record that may be redeemed for money or otherwise monetized by the issuer;
2 B. A gift obligation; or
3 C. A stored-value obligation.

4 **14. Mineral.** "Mineral" means gas, oil, coal, oil shale, other gaseous, liquid or solid
5 hydrocarbon, cement material, sand and gravel, road material, building stone, chemical
6 raw material, gemstone, fissionable and nonfissionable ores, colloidal and other clay,
7 steam and other geothermal resources and any other substance defined as a mineral by
8 law of this State other than this Act.

9 **15. Mineral proceeds.** "Mineral proceeds" means an amount payable for extraction,
10 production or sale of minerals or, on the abandonment of the amount, an amount that
11 becomes payable after abandonment. "Mineral proceeds" includes an amount payable:

- 12 A. For the acquisition and retention of a mineral lease, including a bonus, royalty,
13 compensatory royalty, shut-in royalty, minimum royalty and delay rental;
14 B. For the extraction, production or sale of minerals, including a net revenue interest,
15 royalty, overriding royalty, extraction payment and production payment; and
16 C. Under an agreement or option, including a joint operating agreement, unit
17 agreement, pooling agreement and farm-out agreement.

18 **16. Money order.** "Money order" means a payment order for a specified amount of
19 money. "Money order" includes an express money order and a personal money order on
20 which the remitter is the purchaser. "Money order" does not include a bank money order
21 or any other instrument sold by a financial organization if the seller has obtained the
22 name and address of the payee.

23 **17. Municipal bond.** "Municipal bond" means a bond or evidence of indebtedness
24 issued by a municipality or other political subdivision of a state.

25 **18. Net obligation value.** "Net obligation value" means the original purchase price
26 or original issued value of a stored-value or gift obligation, plus amounts added to the
27 original price or value, if applicable, minus amounts used and any service charge, fee or
28 dormancy charge permitted by law.

29 **19. Nonfreely transferable security.** "Nonfreely transferable security" means a
30 security that cannot be delivered to the administrator by the Depository Trust and
31 Clearing Corporation or similar custodian of securities providing post-trade clearing and
32 settlement services to financial markets or cannot be delivered because there is no agent
33 to effect transfer. "Nonfreely transferable security" includes a worthless security.

34 **20. Owner.** "Owner" means a person that has a legal, beneficial or equitable interest
35 in property subject to this Act or the person's legal representative when acting on behalf
36 of the person. "Owner" includes:

- 37 A. A depositor, for a deposit;
38 B. A beneficiary, for a trust other than a deposit in trust;

1 C. A claimant, or payee, for other property; and
2 D. The lawful bearer of a record that may be used to obtain money, a reward or a
3 thing of value.

4 **21. Payroll card.** "Payroll card" means a record that evidences a payroll card
5 account as defined in Regulation E, 12 Code of Federal Regulations, Part 1005, as
6 amended.

7 **22. Person.** "Person" means an individual, estate, business association, public
8 corporation, government or governmental subdivision, agency or instrumentality or other
9 legal entity, whether or not for profit.

10 **23. Property.** "Property" means tangible property described in section 2065 or a
11 fixed and certain interest in intangible property held, issued or owed in the course of a
12 holder's business or by a government or governmental subdivision, agency or
13 instrumentality. "Property":

14 A. Includes all income from or increments to the property;

15 B. Includes property referred to as or evidenced by:

16 (1) Money, interest or a dividend, check, draft or depositor payroll card;

17 (2) A credit balance, customer's overpayment, stored-value obligation, security
18 deposit, refund, credit memorandum, unpaid wage, unused ticket for which the
19 issuer has an obligation to provide a refund, mineral proceeds or unidentified
20 remittance;

21 (3) A security, except for:

22 (a) A worthless security; or

23 (b) A security that is subject to a lien, legal hold or restriction evidenced on
24 the records of the holder or imposed by operation of law, if the lien, legal
25 hold or restriction restricts the holder's or owner's ability to receive, transfer,
26 sell or otherwise negotiate the security;

27 (4) A bond, debenture, note or other evidence of indebtedness;

28 (5) Money deposited to redeem a security, make a distribution or pay a dividend;

29 (6) An amount due and payable under an annuity contract or insurance policy;
30 and

31 (7) An amount distributable from a trust or custodial fund established under a
32 plan to provide a health, welfare, pension, vacation, severance, retirement, death,
33 stock purchase, profit sharing, employee savings, supplemental unemployment
34 insurance or similar benefit; and

35 C. Does not include a loyalty obligation.

36 **24. Putative holder.** "Putative holder" means a person believed by the administrator
37 to be a holder, until the person pays or delivers to the administrator property subject to

1 this Act or the administrator or a court makes a final determination that the person is or is
2 not a holder.

3 **25. Record.** "Record" means information that is inscribed on a tangible medium or
4 that is stored in an electronic or other medium and is retrievable in perceivable form.
5 "Record," with regard to records of a holder, includes records maintained by a 3rd party
6 that has contracted with the holder.

7 **26. Security.** "Security" means:

8 A. A security as defined in Title 11, Article 8-A;

9 B. A security entitlement as defined in Title 11, Article 8-A, including a customer
10 security account held by a registered broker-dealer, to the extent the financial assets
11 held in the security account are not:

12 (1) Registered on the books of the issuer in the name of the person for which the
13 broker-dealer holds the assets;

14 (2) Payable to the order of the person; or

15 (3) Specifically indorsed to the person; or

16 C. An equity interest in a business association not included in paragraph A or B.

17 **27. Sign.** "Sign" means, with present intent to authenticate or adopt a record:

18 A. To execute or adopt a tangible symbol; or

19 B. To attach to or logically associate with the record an electronic symbol, sound or
20 process.

21 **28. State.** "State" means a state of the United States, the District of Columbia, the
22 Commonwealth of Puerto Rico, the United States Virgin Islands or any territory or
23 insular possession subject to the jurisdiction of the United States.

24 **29. Stored-value obligation.** "Stored-value obligation" means a record evidencing a
25 promise made for consideration by the seller or issuer of the record that goods, services or
26 money will be provided to the owner of the record in the amount of the value or amount
27 shown in the record. "Stored-value obligation":

28 A. Includes a record that contains or consists of a microprocessor chip, magnetic
29 strip or other means for the storage of information, that is prefunded and the value or
30 amount of which is decreased on each use and increased by payment of additional
31 consideration; and

32 B. Does not include a loyalty obligation or gift obligation.

33 **30. United States savings bond.** "United States savings bond" means property,
34 tangible or intangible, in the form of a savings bond issued by the United States Treasury
35 whether in paper form, electronic form or paperless form, along with all the proceeds of
36 the savings bond.

1 **31. Utility.** "Utility" means a person that owns or operates for public use a plant,
2 equipment, real property, franchise or license for the following public services:

3 A. Transmission of communications or information;

4 B. Production, storage, transmission, sale, delivery or furnishing of electricity, water,
5 steam or gas; or

6 C. Provision of sewage or septic services or trash, garbage or recycling disposal.

7 **32. Worthless security.** "Worthless security" means a security of which the cost of
8 liquidation and delivery to the administrator would exceed the value of the security on the
9 date a report is due under this Act.

10 **§2053. Inapplicability to foreign transaction**

11 This Act does not apply to property held, due and owing in a foreign country if the
12 transaction out of which the property arose was a wholly foreign transaction.

13 **§2054. Rulemaking**

14 The administrator may adopt rules to implement and administer this Act. Rules
15 adopted pursuant to this section are routine technical rules as defined in Title 5, chapter
16 375, subchapter 2-A.

17 **SUBCHAPTER 2**

18 **PRESUMPTION OF ABANDONMENT**

19 **§2061. When property presumed abandoned**

20 Subject to section 2070, the following property is presumed abandoned if it is
21 unclaimed by the apparent owner during the period specified:

22 **1. Traveler's check.** A traveler's check, 15 years after issuance;

23 **2. Money order.** A money order, 7 years after issuance;

24 **3. State or municipal bond.** A state or municipal bond, bearer bond or original
25 issue discount bond, 3 years after the date the bond matures or is called or the obligation
26 to pay the principal of the bond arises, whichever is earlier;

27 **4. Debt of a business association.** A debt of a business association, 3 years after the
28 obligation to pay arises;

29 **5. Payroll card account demand, savings or time deposit.** A payroll card account
30 demand, savings or time deposit, including a deposit that is automatically renewable, 3
31 years after the date of the last indication of interest by the owner or the date of maturity of
32 the deposit, whichever is earlier, except that a deposit that is automatically renewable is
33 deemed matured on its initial date of maturity unless the apparent owner consents in a
34 record on file with the holder to renew at or about the time of the renewal;

1 **6. Money or credit owed.** Money or a credit owed to a customer as a result of a
2 retail business transaction, 3 years after the obligation arose;

3 **7. Amount owed on insurance policy or annuity contract.** An amount owed by an
4 insurance company on a life or endowment insurance policy or an annuity contract that
5 has matured or terminated, 3 years after the obligation to pay arose under the terms of the
6 policy or contract or, if a policy or contract for which an amount is owed on proof of
7 death has not matured by proof of the death of the insured or annuitant:

8 A. With respect to an amount owed on a life or endowment insurance policy, 3 years
9 after the earlier of the date:

10 (1) Of the death of the insured; and

11 (2) The insured has attained the limiting age under the mortality table on which
12 the reserve for the policy is based; and

13 B. With respect to an amount owed on an annuity contract, 3 years after the date of
14 the death of the annuitant;

15 **8. Distributable property.** Property distributable by a business association in the
16 course of dissolution, one year after the property becomes distributable;

17 **9. Property held by a court.** Property held by a court, including property received
18 as proceeds of a class action, one year after the property becomes distributable;

19 **10. Property held by a government.** Property held by a government or
20 governmental subdivision, agency or instrumentality, including municipal bond interest
21 and unredeemed principal under the administration of a paying agent or indenture trustee,
22 one year after the property becomes distributable;

23 **11. Wages, commissions, bonuses or reimbursements.** Wages, commissions,
24 bonuses or reimbursements to which an employee is entitled or other compensation for
25 personal services, one year after the amount becomes payable;

26 **12. Deposit or refund owed by a utility.** A deposit or refund owed to a subscriber
27 by a utility, one year after the deposit or refund becomes payable;

28 **13. Prearranged funeral or burial plan.** Notwithstanding subsection 5, property
29 contained in a prearranged funeral or burial plan described in Title 32, section 1401,
30 including deposits containing funds from such a plan, 3 years after the death of a person
31 on whose behalf funds were paid into the plan;

32 **14. Nonactivated stored-value obligation or electronic payment medium.** Funds
33 represented by a nonactivated stored-value obligation or other nonactivated electronic
34 payment medium that require activation for use, one year after the funds would have
35 otherwise first been available to the owner; and

36 **15. Property not specified.** Property not specified in this section or sections 2062 to
37 2072, 3 years after the owner first has a right to demand the property or the obligation to
38 pay or distribute the property arises, whichever is earlier.

1 **§2062. When tax-deferred retirement account presumed abandoned**

2 **1. Presumed abandoned after 3 years.** Subject to section 2070, property held in a
3 pension account or retirement account that qualifies for tax deferral under the income tax
4 laws of the United States is presumed abandoned if it is unclaimed by the apparent owner
5 3 years after the later of:

6 A. The later of the following dates:

7 (1) Except as in subparagraph (2), the date a communication sent by the holder
8 by first class United States mail to the apparent owner is returned to the holder as
9 undeliverable by the United States Postal Service; and

10 (2) If the returned communication is resent within 30 days, the date the resent
11 communication was returned as undeliverable by the United States Postal
12 Service; and

13 B. The earlier of the following dates:

14 (1) The date the apparent owner becomes 70 1/2 years of age; and

15 (2) If the federal Internal Revenue Code of 1986, as amended, requires
16 distribution to avoid a tax penalty, the date the holder:

17 (a) Receives confirmation of the death of the apparent owner in the ordinary
18 course of its business; or

19 (b) Confirms the death of the apparent owner under subsection 2.

20 **2. Confirmation of death of apparent owner.** If a holder in the ordinary course of
21 its business receives notice or an indication of the death of an apparent owner and
22 subsection 1, paragraph B applies, the holder shall attempt not later than 90 days after
23 receipt of the notice or indication to confirm whether the apparent owner is deceased.

24 **3. Confirmation of apparent owner's interest.** If the holder does not send
25 communications to the apparent owner of an account described in subsection 1 by first
26 class United States mail on at least an annual basis, the holder shall attempt to confirm
27 the apparent owner's interest in the property by sending the apparent owner an e-mail not
28 later than 2 years after the apparent owner's last indication of interest in the property.
29 However, the holder promptly shall attempt to contact the apparent owner by first class
30 United States mail if:

31 A. The holder does not have information needed to send the apparent owner an e-
32 mail or the holder believes that the apparent owner's e-mail address in the holder's
33 records is not valid;

34 B. The holder receives notification that the e-mail was not received; or

35 C. The apparent owner does not respond to the e-mail within 30 days after the e-mail
36 was sent.

1 **§2063. When other tax-deferred account presumed abandoned**

2 **1. Presumed abandoned after 3 years.** Subject to section 2070 and except for
3 property described in section 2062, property held in an account or plan, including a health
4 savings account, that qualifies for tax deferral under the income tax laws of the United
5 States is presumed abandoned if it is unclaimed by the apparent owner 3 years after the
6 earlier of:

7 A. The date, if determinable by the holder, specified in the income tax laws and
8 regulations of the United States by which distribution of the property must begin to
9 avoid a tax penalty, with no distribution having been made; and

10 B. Thirty years after the date the account or plan was opened.

11 **2. Presumed abandoned after 2 years.** If the owner is deceased, property under
12 subsection 1 is presumed abandoned 2 years from the earliest of:

13 A. The date of the distribution or attempted distribution of the property;

14 B. The date of the required distribution as stated in the plan or trust agreement
15 governing the plan; and

16 C. The date, if determinable by the holder, specified in the income tax laws of the
17 United States by which distribution of the property must begin in order to avoid a tax
18 penalty.

19 **§2064. When custodial account for minor presumed abandoned**

20 **1. Presumed abandoned after 3 years.** Subject to section 2070, and except as
21 provided in subsection 3, property held in an account established under a state's Uniform
22 Gifts to Minors Act or Uniform Transfers to Minors Act, if it is unclaimed by or on
23 behalf of the minor on whose behalf the account was opened, is presumed abandoned 3
24 years after the later of:

25 A. The date a communication sent by the holder by first class United States mail to
26 the custodian of the minor on whose behalf the account was opened is returned as
27 undeliverable to the holder by the United States Postal Service or, if the
28 communication is resent within 30 days after the date the first communication is
29 returned as undeliverable, the date the first communication was returned as
30 undeliverable; and

31 B. The date on which the custodian is required to transfer the property to the minor
32 or the minor's estate in accordance with the Uniform Gifts to Minors Act or Uniform
33 Transfers to Minors Act of the state in which the account was opened.

34 **2. Confirmation of custodian's interest.** If the holder does not send
35 communications to the custodian of the minor on whose behalf an account described in
36 subsection 1 was opened by first class United States mail on at least an annual basis, the
37 holder shall attempt to confirm the custodian's interest in the property by sending the
38 custodian an e-mail not later than 2 years after the custodian's last indication of interest in
39 the property. However, the holder promptly shall attempt to contact the custodian by first
40 class United States mail if:

- 1 A. The holder does not have information needed to send the custodian an e-mail or
2 the holder believes that the custodian's e-mail address in the holder's records is not
3 valid;
4 B. The holder receives notification that the e-mail was not received; or
5 C. The custodian does not respond to the e-mail within 30 days after the e-mail was
6 sent.

7 **3. If undeliverable, presumed abandoned after 3 years.** If first class United States
8 mail sent under subsection 2 is returned as undeliverable to the holder by the United
9 States Postal Service, the property is presumed abandoned 3 years after the later of:

- 10 A. The date a 2nd consecutive communication to contact the custodian by first class
11 United States mail is returned to the holder as undeliverable by the United States
12 Postal Service; and
13 B. The date established by subsection 1, paragraph C.

14 **4. No longer subject to section.** When the property in the account described in
15 subsection 1 is transferred to the minor on whose behalf the account was opened or to the
16 minor's estate, the property in the account is no longer subject to this section.

17 **§2065. When contents of safe deposit box presumed abandoned**

18 Tangible property held in a safe deposit box or other safekeeping depository in this
19 State in the ordinary course of the holder's business and proceeds resulting from the sale
20 of the property permitted by other law are presumed abandoned if the property and
21 proceeds remain unclaimed by the owner for more than 3 years after expiration of the
22 lease or rental period on the box or other depository.

23 **§2066. When stored-value obligation presumed abandoned**

24 **1. Presumed abandoned after 2 years.** Subject to section 2070, the net obligation
25 value of a stored-value obligation is presumed abandoned on the latest of 2 years after:

- 26 A. December 31st of the year in which the obligation is issued or additional funds
27 are deposited into it;
28 B. The most recent indication of interest in the obligation by the apparent owner; and
29 C. A verification or review of the balance by or on behalf of the apparent owner.

30 **2. Amount presumed abandoned.** The amount presumed abandoned in a stored-
31 value obligation is the net obligation value at the time it is presumed abandoned.

32 **3. No period of limitation, charges or fees; exceptions, disclosure.**
33 Notwithstanding section 2112, fees, charges or a period of limitation may not be imposed
34 on stored-value obligations, except that the issuer may charge a transaction fee for the
35 initial issuance and for each occurrence of adding value to an existing stored-value
36 obligation. These fees must be disclosed in a separate writing prior to the initial issuance
37 or referenced on the stored-value obligation.

1 **4. Redemption; balance in cash.** If a stored-value obligation is redeemed in person
2 and a balance of less than \$5 remains following redemption, at the consumer's request the
3 merchant redeeming the stored-value obligation must refund the balance in cash to the
4 consumer. This subsection does not apply to a stored-value obligation with an initial
5 value of \$5 or less, or a stored-value obligation that is not purchased but provided as a
6 promotion or as a refund for merchandise returned without a receipt.

7 **§2067. When gift obligation presumed abandoned**

8 **1. Presumed abandoned after 2 years.** Subject to section 2070, a gift obligation is
9 presumed abandoned 2 years after December 31st of the year in which the obligation
10 arises or the most recent transaction involving the obligation occurs, whichever is later.

11 **2. Amount unclaimed is 60%.** The amount unclaimed of a gift obligation is 60% of
12 the net obligation value at the time it is presumed abandoned.

13 **3. Not presumed abandoned; sales by a single issuer under \$250,000.** A gift
14 obligation is not presumed abandoned if it was sold by a single issuer who in the past
15 calendar year sold no more than \$250,000 in face value of gift obligations. Sales of gift
16 obligations are considered sales by a single issuer if the sales were by businesses that
17 operate either:

18 A. Under common ownership or control with another business or businesses in the
19 State; or

20 B. As franchised outlets of a parent business.

21 **4. No period of limitation for redemption.** A period of limitation may not be
22 imposed on the owner's right to redeem the gift obligation.

23 **5. No charges or fees; exception, disclosure.** Notwithstanding section 2112, fees or
24 charges may not be imposed on gift obligations, except that the issuer may charge a
25 transaction fee for the initial issuance. The fee must be disclosed in a separate writing
26 prior to the initial issuance or referenced on the gift obligation.

27 **6. Redemption; balance in cash.** If a gift obligation is redeemed in person and a
28 balance of less than \$5 remains following redemption, at the consumer's request the
29 merchant redeeming the gift obligation must refund the balance in cash to the consumer.
30 This subsection does not apply to a gift obligation with an initial value of \$5 or less.

31 **§2068. When security presumed abandoned**

32 **1. If communications sent at least annually, presumed abandoned after 3 years.**
33 Subject to section 2070, if the holder sends communications to the apparent owner of a
34 security by first class United States mail on at least an annual basis, a security is
35 presumed abandoned 3 years after the later of:

36 A. The date a communication sent by the holder by first class United States mail to
37 the apparent owner is returned to the holder as undeliverable by the United States
38 Postal Service; and

1 B. If the communication is resent within 30 days after the first communication is
2 returned, the date the resent communication is returned as undeliverable to the holder
3 by the United States Postal Service.

4 **2. If no communications sent, duty to confirm owner's interest not later than 2**
5 **years.** If the holder does not send communications to the apparent owner of a security by
6 first class United States mail, the holder shall attempt to confirm the apparent owner's
7 interest in the security by sending the apparent owner an e-mail not later than 2 years
8 after the apparent owner's last indication of interest in the security. However, the holder
9 promptly shall attempt to contact the apparent owner by first class United States mail if:

10 A. The holder does not have information needed to send the apparent owner an e-
11 mail or the holder believes that the apparent owner's e-mail address in the holder's
12 records is not valid;

13 B. The holder receives notification that the e-mail was not received; or

14 C. The apparent owner does not respond to the e-mail within 30 days after the e-mail
15 was sent.

16 **3. If confirmation returned undeliverable, presumed abandoned after 3 years.**
17 If first class United States mail sent under subsection 2 is returned to the holder as
18 undeliverable by the United States Postal Service, the security is presumed abandoned 3
19 years after the latest indication of interest by the apparent owner in the security.

20 **4. Presumed abandoned 2 years after death of owner.** Notwithstanding the
21 standards set forth in subsection 1, if the owner is deceased, the security is presumed
22 abandoned 2 years after the date of death of the owner.

23 **§2069. When related property presumed abandoned**

24 At and after the time property is presumed abandoned under this Act, any other
25 property right or interest accrued or accruing from the property and not previously
26 presumed abandoned is also presumed abandoned.

27 **§2070. Indication of apparent owner**

28 **1. Period of abandonment.** The period after which property is presumed
29 abandoned is measured from the later of:

30 A. The date the property is presumed abandoned under this subchapter; and

31 B. The latest indication of interest by the apparent owner in the property.

32 **2. Indication of interest.** Under this Act, an indication of an apparent owner's
33 interest in property includes:

34 A. A record communicated by the apparent owner to the holder or agent of the
35 holder concerning the property or the account in which the property is held;

36 B. An oral communication by the apparent owner to the holder or agent of the holder
37 concerning the property or the account in which the property is held, if the holder or

1 its agent contemporaneously makes and preserves a record of the fact of the apparent
2 owner's communication;

3 C. Presentment by the apparent owner of a check or other instrument of payment of a
4 dividend, interest payment or other distribution, or evidence of receipt of a
5 distribution made by electronic or similar means, with respect to an account,
6 underlying security or interest in a business association;

7 D. Activity by the apparent owner in the account in which the property is held,
8 including accessing the account balance, or a request by the apparent owner to
9 increase, decrease or otherwise change the amount or type of property held in the
10 account;

11 E. A deposit into or withdrawal from an account at a financial organization by the
12 apparent owner, except for an automatic withdrawal previously authorized or an
13 automatic reinvestment of dividends or interest;

14 F. Subject to subsection 4, payment by the apparent owner of a premium on an
15 insurance policy; and

16 G. For deposits in which the apparent owner has another relationship or account with
17 the holder:

18 (1) The fact that the apparent owner has indicated interest with respect to the
19 other relationships or accounts; or

20 (2) The fact that there is a memorandum or other record on file prepared by the
21 holder indicating that the holder has communicated in writing with the apparent
22 owner with regard to the deposit at the address to which communications
23 regarding the other relationships or deposits are regularly sent.

24 **3. Action of agent.** Action by an agent of an apparent owner, other than the holder
25 acting as the apparent owner's agent, is presumed to be an action on behalf of the
26 apparent owner.

27 **4. Nonforfeiture provision.** Application of an automatic premium loan provision or
28 other nonforfeiture provision contained in an insurance policy is not an indication of
29 interest in the policy and does not prevent the policy from maturing or terminating if the
30 insured has died or the insured or the beneficiary of the policy otherwise has become
31 entitled to the proceeds before depletion of the cash surrender value of the policy by
32 application of the provision.

33 **§2071. Deposit account for proceeds of insurance policy or annuity**

34 If proceeds payable under a life or endowment insurance policy or annuity contract
35 are deposited into an account with check-writing or draft-writing privileges for the
36 beneficiary of the policy or contract and, under a supplementary contract not involving
37 annuity benefits other than death benefits, the proceeds are retained by the insurance
38 company or the financial organization where the account is held, the policy or contract
39 includes the assets in the account.

1 **§2072. When United States savings bonds are presumed abandoned**

2 **1. Presumed abandoned.** Notwithstanding section 2061, subsection 9 and sections
3 2112 and 2131, a United States savings bond subject to this chapter or held or owing in
4 this State by any person is presumed abandoned in this State if:

5 A. The last known address of the owner of the United States savings bond is in this
6 State; and

7 B. The United States savings bond has remained unclaimed for 3 years after its date
8 of final maturity.

9 **2. Escheat; procedure.** United States savings bonds that are presumed abandoned
10 and unclaimed under subsection 1, including bonds in the possession of the administrator,
11 and those lost, stolen or destroyed bonds registered to persons with last known addresses
12 in this State, escheat to the State 3 years after the bonds are presumed abandoned, and all
13 property rights and legal title to and ownership of the United States savings bonds,
14 including all rights, powers and privileges of survivorship of any owner, co-owner or
15 beneficiary, vest solely in the State according to the following procedure.

16 A. Within 180 days after the 3-year period in this subsection has passed, if no claim
17 has been filed in accordance with this chapter for the United States savings bonds, the
18 administrator shall commence a civil action in the Kennebec County Superior Court
19 or in any other court of competent jurisdiction for a determination that the United
20 States savings bonds escheat to the State. The administrator may postpone the
21 bringing of such an action until sufficient United States savings bonds have
22 accumulated in the administrator's custody to justify the expense of such a
23 proceeding.

24 B. The administrator shall make service by publication of the civil action in
25 accordance with the Maine Rules of Civil Procedure, Rule 4 and Title 1, sections 601
26 and 603.

27 C. If no person files a claim or appears at the hearing to substantiate a claim or if the
28 court determines that a claimant is not entitled to the property claimed by the
29 claimant, the court, if satisfied by evidence that the administrator has substantially
30 complied with the laws of this State, shall enter a judgment that the United States
31 savings bonds have escheated to the State and all property rights and legal title to and
32 ownership of the United States savings bonds, including all rights, powers and
33 privileges of survivorship of any owner, co-owner or beneficiary, vest solely in the
34 State.

35 D. The administrator shall redeem the United States savings bonds escheated to the
36 State. When the escheated proceeds have been recovered by the administrator, the
37 administrator shall first pay all costs incident to the collection and recovery of the
38 proceeds from the redemption of the United States savings bonds and then promptly
39 deposit the remaining balance of the proceeds in the Unclaimed Property Fund under
40 section 2141 to be distributed in accordance with law.

41 **3. Claims after escheat.** Notwithstanding subchapter 9, any person making a claim
42 for a United States savings bond escheated to the State under this section may file a claim

1 with the administrator. Upon being provided sufficient proof of the validity of the
2 person's claim, the administrator may pay the claim and may subtract any expenses and
3 costs incurred by the State in securing full title and ownership of the property by escheat.
4 If payment has been made to a claimant, no action may be maintained by any other
5 claimant or the State or any state officer for or on account of the funds.

6 SUBCHAPTER 3

7 RULES FOR TAKING CUSTODY OF PROPERTY PRESUMED ABANDONED

8 §2081. Address of apparent owner to establish priority

9 In this subchapter, the following rules apply:

10 1. Last known address. The last known address of an apparent owner, as shown in
11 the records of the holder, is any description, code or other indication of the location of the
12 apparent owner that identifies the state, even if the description, code or indication of
13 location is not sufficient to direct the delivery of first class United States mail to the
14 apparent owner.

15 2. Zip code in this State; exception. If the zip code associated with the apparent
16 owner is for a post office located in this State, this State is deemed to be the state of the
17 last known address of the apparent owner unless other records associated with the
18 apparent owner specifically identify the physical address of the apparent owner in another
19 state.

20 3. Physical address in another state. If the address under subsection 2 is in another
21 state, the other state is deemed to be the state of the last known address of the apparent
22 owner.

23 4. Address of insured or annuitant. The address of the apparent owner of a life or
24 endowment insurance policy or annuity contract or its proceeds is presumed to be the
25 address of the insured or annuitant if a person other than the insured or annuitant is
26 entitled to the amount owed under the policy or contract and the address of the other
27 person is not known by the insurance company and cannot be determined under section
28 2082.

29 §2082. Address of apparent owner in this State

30 The administrator may take custody of property that is presumed abandoned, whether
31 located in this State, another state or a foreign country if:

32 1. Last known address in records of holder. The last known address of the
33 apparent owner in the records of the holder is in this State; or

34 2. Determination by administrator. The records of the holder do not reflect the
35 identity or last known address of the apparent owner, but the administrator has
36 determined that the last known address of the apparent owner is in this State.

1 **§2083. If records show multiple addresses of apparent owner**

2 **1. Most recently recorded address.** Except as in subsection 2, if records of a
3 holder reflect multiple addresses for an apparent owner and this State is the state of the
4 most recently recorded address, this State may take custody of property presumed
5 abandoned, whether located in this State or another state.

6 **2. Next most recently recorded address.** If it appears from records of the holder
7 that the most recently recorded address of the apparent owner under subsection 1 is a
8 temporary address and this State is the state of the next most recently recorded address
9 that is not a temporary address, this State may take custody of the property presumed
10 abandoned.

11 **§2084. Holder domiciled in this State**

12 **1. Holder domiciled in this State.** Except as in subsection 2 or section 2082 or
13 2083, the administrator may take custody of property presumed abandoned, whether
14 located in this State, another state or a foreign country, if the holder is domiciled in this
15 State or is this State or a governmental subdivision, agency or instrumentality of this
16 State and:

17 **A. Another state or foreign country is not entitled to the property because there is no**
18 **last known address of the apparent owner or other person entitled to the property in**
19 **the records of the holder; or**

20 **B. The state or foreign country of the last known address of the apparent owner or**
21 **other person entitled to the property does not provide for custodial taking of the**
22 **property.**

23 **2. Holder deemed domiciled.** If a holder's state of domicile has changed since the
24 time property was presumed abandoned, the holder's state of domicile in this section is
25 deemed to be the state where the holder was domiciled at the time the property was
26 presumed abandoned.

27 **§2085. Custody if transaction took place in this State**

28 **Except as in section 2082, 2083 or 2084, the administrator may take custody of**
29 **property presumed abandoned whether located in this State or another state if:**

30 **1. Transaction in this State.** The transaction out of which the property arose took
31 place in this State;

32 **2. Holder's domicile in another state.** The holder is domiciled in a state that does
33 not provide for the custodial taking of the property; and

34 **3. Apparent owner or other person entitled.** The last known address of the
35 apparent owner or other person entitled to the property is unknown or in a state that does
36 not provide for the custodial taking of the property.

1 D. Except for a traveler's check, money order or similar instrument, contain the
2 name, if known, last known address, if known, and social security number or
3 taxpayer identification number, if known or readily ascertainable;

4 E. For an amount held or owing under a life or endowment insurance policy, annuity
5 contract or other property for which ownership vests in a beneficiary upon the death
6 of the owner, contain the name and last known address of the insured, annuitant or
7 other apparent owner of the policy or contract and of the beneficiary;

8 F. For property held in or removed from a safe deposit box, indicate the location of
9 the property, where it may be inspected by the administrator and any amounts owed
10 to the holder under section 2116;

11 G. Contain the commencement date for determining abandonment under subchapter
12 2;

13 H. State that the holder has complied with the notice requirements of section 2101;

14 I. Identify property that is a nonfreely transferable security and explain why it is a
15 nonfreely transferable security; and

16 J. Contain other information the administrator prescribes by rule.

17 **2. Aggregate items valued under \$50.** A report under section 2091 may include in
18 the aggregate items valued under \$50 each for which personal information, as defined in
19 section 2211, subsection 1, concerning the owner is unknown.

20 **3. Personal information.** A report under section 2091 may include personal
21 information as defined in section 2211, subsection 1 about the apparent owner or the
22 apparent owner's property.

23 **4. Former name, name of previous holder.** If a holder has changed its name while
24 holding property presumed abandoned or is a successor to another person that previously
25 held the property for the apparent owner, the holder must include in the report under
26 section 2091 its former name or the name of the previous holder, if any, and the known
27 name and address of each previous holder of the property.

28 **§2093. When report filed**

29 **1. November 1st.** Except as otherwise provided in subsection 2 and subject to
30 subsection 3, the report under section 2091 must be filed before November 1st of each
31 year and cover the 12 months preceding July 1st of that year.

32 **2. May 1st.** Subject to subsection 3, a report under section 2091 containing
33 information about life insurance policies, gift obligations and stored-value obligations
34 must be filed before May 1st of each year for the immediately preceding calendar year.

35 **3. Extension; payment.** Before the date for filing the report under section 2091, the
36 holder of property presumed abandoned may request the administrator to extend the time
37 for filing. The administrator may grant an extension. If the extension is granted, the
38 administrator may require the holder to pay or make a partial payment of the amount the

1 holder estimates ultimately will be due. The payment or partial payment terminates
2 accrual of interest on the amount paid.

3 **§2094. Retention of records by holder**

4 A holder required to file a report under section 2091 shall retain records for 10 years
5 after the date the report was filed or the last date a timely report was due to be filed,
6 whichever is later, unless a shorter period is provided by rule of the administrator. The
7 holder may satisfy the requirement to retain records under this section through an agent.
8 The records must contain:

9 **1. Required information.** The information required to be included in the report;

10 **2. Date, place, nature of circumstances.** The date, place and nature of the
11 circumstances that gave rise to the property right;

12 **3. Amount or value.** The amount or value of the property;

13 **4. Last known address of apparent owner.** The last known address of the apparent
14 owner, if known to the holder;

15 **5. Items not reported unclaimed.** Records of items that were not reported as
16 unclaimed sufficient to allow examination to determine whether the holder has complied
17 with the Act; and

18 **6. Record of outstanding instruments.** If the holder sells, issues or provides to
19 others for sale or issue in this State traveler's checks, money orders or similar instruments,
20 other than 3rd-party bank checks, on which the holder is directly liable, a record of the
21 instruments while they remain outstanding indicating the state and date of issue.

22 **§2095. Property reportable and payable or deliverable absent owner demand**

23 Property is reportable and payable or deliverable under this Act even if the owner
24 fails to make demand or present an instrument or document otherwise required to obtain
25 payment.

26 **SUBCHAPTER 5**

27 **NOTICE TO APPARENT OWNER OF PROPERTY PRESUMED ABANDONED**

28 **§2101. Notice to apparent owner by holder**

29 **1. Notice to apparent owner.** Subject to subsection 2, the holder of property
30 presumed abandoned shall send to the apparent owner notice by first class United States
31 mail that complies with section 2102 in a format acceptable to the administrator not more
32 than 180 days nor less than 60 days before filing the report under 2091 if:

33 A. The holder has in its records an address for the apparent owner that the holder's
34 records do not disclose to be invalid and is sufficient to direct the delivery of first
35 class United States mail to the apparent owner; and

1 B. The value of the property held for an owner in aggregate is \$50 or more.

2 2. E-mail. If an apparent owner has consented to receive e-mail delivery from the
3 holder, the holder shall send the notice described in subsection 1 both by first class
4 United States mail to the apparent owner's last known mailing address and by e-mail,
5 unless the holder believes that the apparent owner's e-mail address is invalid.

6 3. Notice; tax deferred account or security. The holder of securities presumed
7 abandoned under section 2062, 2063 or 2068 shall send to the apparent owner notice by
8 certified United States mail that complies with section 2102 in a format acceptable to the
9 administrator not less than 60 days before filing the report under section 2091 if:

10 A. The holder has in its records an address for the apparent owner that the holder's
11 records do not disclose to be invalid and that is sufficient to direct the delivery of
12 United States mail to the apparent owner; and

13 B. The value of the property is \$1,000 or more.

14 4. Return receipt constitutes record communicated by apparent owner. In
15 addition to other indications of an apparent owner's interest in property pursuant to
16 section 2070, a signed return receipt in response to a notice sent pursuant to this section
17 by certified United States mail constitutes a record communicated by the apparent owner
18 to the holder concerning the property or the account in which the property is held.

19 **§2102. Contents of notice by holder**

20 1. Notice heading. Notice under section 2101 must contain a heading that reads
21 substantially as follows: "Notice. The State of Maine requires us to notify you that your
22 property may be transferred to the custody of the State Treasurer if you do not contact us
23 before (insert date that is 30 days after the date of this notice)."

24 2. Notice contents. The notice under section 2101 must:

25 A. Identify the nature and, except for property that does not have a fixed value, the
26 value of the property that is the subject of the notice;

27 B. State that the property will be turned over to the administrator;

28 C. State that after the property is turned over to the administrator an apparent owner
29 that seeks return of the property must file a claim with the administrator;

30 D. State that property that is not legal tender of the United States may be sold by the
31 administrator; and

32 E. Provide instructions that the apparent owner must follow to prevent the holder
33 from reporting and paying or delivering the property to the administrator.

34 **§2103. Notice by administrator**

35 1. Website; apparent owners. The administrator shall maintain a website
36 accessible by the public and electronically searchable that contains the names reported to
37 the administrator of all apparent owners for whom property is being held by the
38 administrator. The administrator may exclude certain properties from publication on this

1 website if reasonable exclusion serves the best interest of the State and the owner of the
2 property.

3 **2. Instructions for filing.** The website must include instructions for filing with the
4 administrator a claim to property.

5 **3. Other communications and media.** The administrator may use any printed
6 publication, telecommunication, the Internet or other media to inform the public of the
7 existence of unclaimed property held by the administrator.

8 **§2104. Cooperation among state officers and agencies to locate apparent owner**

9 Unless prohibited by law of this State other than this Act, on request of the
10 administrator, each officer, agency, board, commission, division and department of this
11 State, any body politic and corporate created by this State for a public purpose, and each
12 political subdivision of this State shall make its books and records available to the
13 administrator and cooperate with the administrator to determine the current address of an
14 apparent owner of property held by the administrator under this Act or to otherwise assist
15 the administrator in the administration of this Act. The administrator may also enter into
16 data-sharing agreements to enable other governmental agencies to provide an additional
17 notice to apparent owners of property held by the administrator.

18 **SUBCHAPTER 6**

19 **TAKING CUSTODY OF PROPERTY BY ADMINISTRATOR**

20 **§2111. Definition of good faith**

21 In this subchapter, payment or delivery of property is made in good faith if a holder:

22 **1. Reasonable basis.** Had a reasonable basis for believing, based on the facts then
23 known, that the property was required or permitted to be paid or delivered to the
24 administrator under this Act; or

25 **2. Payment or delivery.** Made payment or delivery:

26 A. In response to a demand by the administrator or administrator's agent; or

27 B. Under a guidance or ruling issued by the administrator that the holder reasonably
28 believed required or permitted the property to be paid or delivered.

29 **§2112. Dormancy charge**

30 **1. Deduct dormancy charge.** A holder may deduct a dormancy charge from
31 property required to be paid or delivered to the administrator if:

32 A. A valid contract between the holder and the apparent owner authorizes imposition
33 of the charge for the apparent owner's failure to claim the property within a specified
34 time; and

35 B. The holder regularly imposes the charge and regularly does not reverse or
36 otherwise cancel the charge.

1 **2. Not unconscionable amount.** The amount of the deduction under subsection 1 is
2 limited to an amount that is not unconscionable considering all relevant factors, including
3 the marginal transactional costs incurred by the holder in maintaining the apparent
4 owner's property and any services received by the apparent owner.

5 **§2113. Payment or delivery of property to administrator**

6 **1. Payment or delivery.** Except as otherwise provided in this section, on filing a
7 report under section 2091, the holder shall pay or deliver to the administrator the property
8 described in the report.

9 **2. Extension of date.** If property in a report under section 2091 is an automatically
10 renewable deposit and a penalty or forfeiture in the payment of interest would result from
11 paying the deposit to the administrator at the time of the report, the date for payment of
12 the property to the administrator is extended until a penalty or forfeiture no longer would
13 result from payment, if the holder informs the administrator of the extended date.

14 **3. Delivery of tangible property in safe deposit box.** Tangible property in a safe
15 deposit box may not be delivered to the administrator until a mutually agreed upon date
16 no sooner than 120 days after filing the report under section 2091.

17 **4. Security.** If property reported to the administrator under section 2091 is a
18 security, the administrator may:

19 A. Make an endorsement, instruction or entitlement order on behalf of the apparent
20 owner to invoke the duty of the issuer, its transfer agent or the securities intermediary
21 to transfer the security; or

22 B. Dispose of the security under section 2132.

23 **5. Issuer of certificated security.** If the holder of property reported to the
24 administrator under section 2091 is the issuer of a certificated security, the administrator
25 may obtain a replacement certificate in physical or book-entry form under Title 11,
26 section 8-1405. An indemnity bond is not required.

27 **6. Securities procedures.** The administrator shall establish procedures for the
28 registration, issuance, method of delivery, transfer and maintenance of securities
29 delivered to the administrator by a holder.

30 **7. No liability after delivered.** An issuer, holder and transfer agent or other person
31 acting in good faith under this section under instructions of and on behalf of the issuer or
32 holder is not liable to the apparent owner for, and must be indemnified by the State
33 against, a claim arising with respect to property after the property has been delivered to
34 the administrator.

35 **8. Nonfreely transferable security.** A holder is not required to deliver to the
36 administrator a security identified by the holder as a nonfreely transferable security. If
37 the administrator or holder determines that a security is no longer a nonfreely transferable
38 security, the holder shall deliver the security on the next regular date prescribed for
39 delivery of securities under this Act. The holder shall make a determination annually

1 whether a security identified in a report filed under section 2091 as a nonfreely
2 transferable security is no longer a nonfreely transferable security.

3 **§2114. Effect of payment or delivery of property to administrator**

4 **1. No liability of holder on payment or delivery.** On payment or delivery of
5 property to the administrator under this Act, the administrator as agent for the State
6 assumes custody and responsibility for safekeeping the property. A holder that pays or
7 delivers property to the administrator in good faith and substantially complies with
8 sections 2101 and 2102 is relieved of liability arising thereafter with respect to payment
9 or delivery of the property to the administrator.

10 **2. State indemnification.** This State shall defend and indemnify a holder against
11 liability on a claim against the holder resulting from the payment or delivery of property
12 to the administrator made in good faith and after the holder substantially complied with
13 sections 2101 and 2102.

14 **§2115. Recovery of property by holder from administrator**

15 **1. Claim for reimbursement.** A holder that under this Act pays money to the
16 administrator may file a claim for reimbursement from the administrator of the amount
17 paid if the holder:

18 A. Paid the money in error; or

19 B. After paying the money to the administrator, paid money to a person the holder
20 reasonably believed entitled to the money.

21 **2. Proof instrument presented and paid.** If a claim for reimbursement under
22 subsection 1 is made for a payment made on a negotiable instrument, including a
23 traveler's check, money order or similar instrument, the holder must submit proof that the
24 instrument was presented and payment was made to a person the holder reasonably
25 believed entitled to payment. The holder may claim reimbursement even if the payment
26 was made to a person whose claim was made after expiration of a period of limitation on
27 the owner's right to receive or recover property, whether specified by contract, statute or
28 court order.

29 **3. Income or gain.** If a holder is reimbursed by the administrator under subsection
30 1, paragraph B, the holder may also recover from the administrator income or gain under
31 section 2117 that would have been paid to the owner if the money had been claimed from
32 the administrator by the owner to the extent the income or gain was paid by the holder to
33 the owner.

34 **4. Property other than money, claim for return.** A holder that under this Act
35 delivers property other than money to the administrator may file a claim for return of the
36 property from the administrator if:

37 A. The holder delivered the property in error; or

38 B. The apparent owner has claimed the property from the holder.

1 **5. Evidence property claimed.** If a claim for return of property under subsection 4
2 is made, the holder shall include with the claim evidence sufficient to establish that the
3 apparent owner has claimed the property from the holder or that the property was
4 delivered by the holder to the administrator in error.

5 **6. Affidavit sufficient.** The administrator may determine that an affidavit submitted
6 by a holder is evidence sufficient to establish that the holder is entitled to reimbursement
7 or to recover property under this section.

8 **7. No fee or other charge.** A holder is not required to pay a fee or other charge for
9 reimbursement or return of property under this section.

10 **8. Determination on claim.** Not later than 90 days after a claim is filed under
11 subsection 1 or 4, the administrator shall allow or deny the claim and give the claimant
12 notice of the decision in a record. If the administrator does not take action on a claim
13 during the 90-day period, the claim is deemed denied.

14 **9. Claim in Superior Court.** A person aggrieved by a decision of the administrator
15 may maintain an original action to establish the claim in the Superior Court of Kennebec
16 County naming the administrator as a defendant.

17 **§2116. Property removed from safe deposit box**

18 Property removed from a safe deposit box and delivered under this Act to the
19 administrator is subject to the holder's right to reimbursement for the cost of opening the
20 box and a lien or contract providing reimbursement to the holder for unpaid rent charges
21 for the box. The administrator shall reimburse the holder from the proceeds remaining
22 after deducting the expense incurred by the administrator in selling the property.

23 **§2117. Crediting income or gain to owner's account**

24 If property other than money is delivered to the administrator, the owner is entitled to
25 receive from the administrator income or gain realized or accrued on the property before
26 the property is sold. If the property was an interest-bearing savings or time deposit, the
27 administrator shall pay interest at the current 10-year average cash pool rate. Interest is
28 calculated from the date the property is delivered to the administrator and ends on the
29 expiration of 10 years after its delivery or the date on which payment is made to the
30 owner, whichever is earlier.

31 **§2118. Administrator's options as to custody**

32 **1. Custody declined.** The administrator may decline to take custody of property
33 reported under section 2091 if the administrator determines that:

34 A. The property has a value less than the estimated expenses of notice and sale of the
35 property; or

36 B. Taking custody of the property would be unlawful.

37 **2. Before presumed abandoned.** A holder may pay or deliver property to the
38 administrator before the property is presumed abandoned under this Act if the holder:

1 A. Provides the apparent owner of the property notice required by section 2101 and
2 provides the administrator evidence of the holder's compliance with this paragraph;

3 B. Includes with the payment or delivery a report regarding the property conforming
4 to section 2092; and

5 C. First obtains the administrator's consent in a record to accept payment or delivery.
6 The holder's request must be in writing.

7 **3. Presumed abandoned.** On payment or delivery of property under subsection 2,
8 the property is presumed abandoned.

9 **§2119. Disposition of property having no substantial value; immunity from liability**

10 **1. Return to holder.** If the administrator takes custody of property delivered under
11 this Act and later determines that the property has no substantial commercial value or that
12 the cost of disposing of the property will exceed the value of the property, the
13 administrator may return the property to the holder or destroy or otherwise dispose of the
14 property.

15 **2. Immunity from liability.** An action or proceeding may not be commenced
16 against the State, an agency of the State, the administrator, another officer, employee or
17 agent of the State or a holder for or because of an act of the administrator under this
18 section, except for intentional misconduct or malfeasance.

19 **§2120. Periods of limitation and repose**

20 **1. Holder's duty to pay or deliver.** Expiration, before, on or after October 1, 2019,
21 of a period of limitation on an owner's right to receive or recover property, whether
22 specified by contract, statute or court order, does not prevent the property from being
23 presumed abandoned or affect the duty of a holder under this Act to file a report or pay or
24 deliver property to the administrator.

25 **2. Proceeding within 10 years after report; tolled.** An action or proceeding may
26 not be maintained by the administrator to enforce this Act in regard to the reporting,
27 delivery or payment of property more than 10 years after the holder specifically identified
28 the property in a report filed with the administrator or gave express notice to the
29 administrator of a dispute regarding the property. In the absence of such a report or other
30 express notice, the period of limitation is tolled. The period of limitation is also tolled by
31 the filing of a report that is fraudulent.

32 **SUBCHAPTER 7**

33 **SALE OF PROPERTY BY ADMINISTRATOR**

34 **§2131. Public sale of property**

35 **1. Sale after one year.** Subject to section 2132, not earlier than one year after
36 receipt of property presumed abandoned, the administrator may sell the property.

1 **2. Notice of sale.** Before selling property under subsection 1, the administrator shall
2 give notice to the public of:

3 A. The date of the sale; and

4 B. The nature of the property.

5 **3. Sale to highest bidder.** A sale under subsection 1 must be to the highest bidder:

6 A. At public sale at a location in this State that the administrator determines to be the
7 most favorable market for the property;

8 B. On the Internet; or

9 C. On another forum the administrator determines is likely to yield the highest net
10 proceeds of sale.

11 **4. Highest bid insufficient.** The administrator may decline the highest bid at a sale
12 under this section and reoffer the property for sale if the administrator determines the
13 highest bid is insufficient.

14 **5. Publication of notice.** If a sale held under this section is to be conducted other
15 than on the Internet, the administrator may publish at least one notice of the sale, at least
16 2 weeks but not more than 10 weeks before the sale.

17 **§2132. Disposal of securities**

18 **1. Sell or liquidate security after one year.** Except as provided in section 2155,
19 subsection 1, the administrator may not sell or otherwise liquidate a security until one
20 year after the administrator receives the security.

21 **2. Price of security.** The administrator may not sell a security listed on an
22 established stock exchange for less than the price prevailing on the exchange at the time
23 of sale. The administrator may sell a security not listed on an established exchange by
24 any commercially reasonable method.

25 **§2133. Recovery of securities or value by owner**

26 **1. Claim for securities sold before one year after delivery.** If securities are sold
27 by the administrator before the expiration of one year after their delivery to the
28 administrator, a person making a claim under this Act before the end of the one-year
29 period is entitled to the proceeds of the sale of the securities or the market value of the
30 securities at the time the claim is made, whichever is greater, plus dividends, interest and
31 other increments thereon up to the time the claim is made, less any deduction for
32 expenses of sale. A person making a claim under this Act after the expiration of the one-
33 year period is entitled to receive the securities delivered to the administrator by the
34 holder, if the securities remain in the custody of the administrator, or the net proceeds
35 received from sale and is not entitled to receive any appreciation in the value of the
36 property occurring after delivery to the administrator, except in a case of intentional
37 misconduct or malfeasance by the administrator.

1 **§2142. Administrator to retain records of property**

2 The administrator shall:

3 **1. Name and address of apparent owners.** Record and retain the name and last
4 known address of each person shown on a report filed under section 2091 to be the
5 apparent owner of property delivered to the administrator;

6 **2. Name and address of insureds, annuitants and beneficiaries.** Record and
7 retain the name and last known address of each insured or annuitant and beneficiary
8 shown on the report;

9 **3. Policy or account number, company and amount.** For each policy of insurance
10 or annuity contract listed in the report of an insurance company, record and retain the
11 policy or account number, the name of the company and the amount due or paid; and

12 **4. Holder that filed report.** For each apparent owner listed in the report, record and
13 retain the name of the holder that filed the report and the amount due or paid.

14 **§2143. Expenses and service charges of administrator**

15 Before making a deposit of funds received under this Act to the Unclaimed Property
16 Fund under section 2141, the administrator may deduct:

17 **1. Expenses of disposition of property.** Expenses of disposition of property
18 delivered to the administrator under this Act;

19 **2. Costs of mailing and publication.** Costs of mailing and publication in
20 connection with property delivered to the administrator under this Act;

21 **3. Reasonable service charges.** Reasonable service charges; and

22 **4. Expenses incurred.** Expenses incurred in examining records of or collecting
23 property from a putative holder or holder.

24 At the end of each year or more often, the administrator shall transfer to the General
25 Fund all money in the Unclaimed Property Fund under section 2141 that is in excess of
26 \$500,000.

27 **§2144. Administrator holds property as custodian for owner**

28 Except as provided in section 2072, property received by the administrator under this
29 Act is held in custody for the benefit of the owner and is not owned by the State.

30 **SUBCHAPTER 9**

31 **CLAIM TO RECOVER PROPERTY FROM ADMINISTRATOR**

1 **§2151. Claim of another state to recover property**

2 **1. Subject to superior claim of another state.** If the administrator knows that
3 property held by the administrator under this Act is subject to a superior claim of another
4 state, the administrator shall:

5 A. Report and pay or deliver the property to the other state; or

6 B. Return the property to the holder so that the holder may pay or deliver the
7 property to the other state.

8 **2. Agreement to transfer not required.** The administrator is not required to enter
9 into an agreement to transfer property to the other state under subsection 1.

10 **§2152. When property subject to recovery by another state**

11 **1. Subject to right of another state.** Property held under this Act by the
12 administrator is subject to the right of another state to take custody of the property if:

13 A. The property was paid or delivered to the administrator because the records of the
14 holder did not reflect a last known address in the other state of the apparent owner
15 and:

16 (1) The other state establishes that the last known address of the apparent owner
17 or other person entitled to the property was in the other state; or

18 (2) Under the law of the other state, the property has become subject to a claim
19 by the other state of abandonment;

20 B. The records of the holder did not accurately identify the owner of the property,
21 the last known address of the owner was in another state and, under the law of the
22 other state, the property has become subject to a claim by the other state of
23 abandonment;

24 C. The property was subject to the custody of the administrator under section 2085
25 and, under the law of the state of domicile of the holder, the property has become
26 subject to a claim by the state of domicile of the holder of abandonment; or

27 D. The property:

28 (1) Is a sum payable on a traveler's check, money order or similar instrument that
29 was purchased in the other state and delivered to the administrator under section
30 2086; and

31 (2) Under the law of the other state, has become subject to a claim by the other
32 state of abandonment.

33 **2. Form prescribed.** A claim by another state to recover property under this section
34 must be presented in a form prescribed by the administrator, unless the administrator
35 waives presentation of the form.

36 **3. Decision within 90 days.** The administrator shall decide a claim under this
37 section not later than 90 days after it is presented. If the administrator determines that the

1 other state is entitled under subsection 1 to custody of the property, the administrator
2 shall allow the claim and pay or deliver the property to the other state.

3 4. May require indemnification. The administrator may require another state,
4 before recovering property under this section, to agree to indemnify this State and its
5 agents, officers and employees against any liability on a claim to the property.

6 **§2153. Claim for property by person claiming to be owner**

7 1. Claim for property. A person claiming to be the owner of property held under
8 this Act by the administrator may file a claim for the property on a form prescribed by the
9 administrator. The claimant must verify the claim as to its completeness and accuracy.

10 2. Waive; pay or deliver directly. The administrator may waive the requirement in
11 subsection 1 and may pay or deliver property directly to a person if:

12 A. The person receiving the property or payment is shown to be the apparent owner
13 included on a report filed under section 2091; and

14 B. The administrator reasonably believes the person is entitled to receive the
15 property or payment.

16 **§2154. When administrator must honor claim for property**

17 1. Administrator shall pay claim. The administrator shall pay or deliver property
18 to a claimant under section 2153, subsection 1 if the administrator receives evidence
19 sufficient to establish to the satisfaction of the administrator that the claimant is the owner
20 of the property.

21 2. Approve or deny claim within 90 days. Not later than 90 days after a claim is
22 filed and completed under section 2153, subsection 1, the administrator shall approve or
23 deny the claim and give the claimant notice in a record of the decision. A claim is
24 complete when a claimant has provided all the information and documentation requested
25 by the administrator necessary to prove legal ownership of the property.

26 3. Claim denied; procedure; amended claim. If the claim is denied under
27 subsection 2:

28 A. The administrator shall inform the claimant of the reason for the denial; and

29 B. The claimant may file an amended claim with the administrator or commence an
30 action under section 2156.

31 4. Claim deemed denied. If the administrator does not take action on a claim
32 during the 90-day period under subsection 2, the claim is deemed denied.

33 **§2155. Allowance of claim for property**

34 1. Pay or deliver within 30 days. Not later than 30 days after a claim is approved
35 under section 2154, subsection 2, the administrator shall pay or deliver to the owner the
36 property or pay to the owner the net proceeds of a sale of the property, together with
37 income or gain to which the owner is entitled under section 2117. On request of the

1 owner, the administrator may sell or liquidate a security and pay the net proceeds to the
2 owner, even if the security had been held by the administrator for less than one year or
3 the administrator has not complied with the notice requirements under section 2131.

4 **2. Subject to claim.** Property held under this Act by the administrator is subject to a
5 claim for the payment of an enforceable debt the owner owes in this State for:

6 A. Child support arrearages, including child support collection costs and child
7 support arrearages that are combined with maintenance;

8 B. A final court judgment; or

9 C. State or federal taxes, penalties and interest that have been determined to be
10 delinquent by the relevant tax authority.

11 **§2156. Action by person whose claim is denied**

12 Not later than one year after being denied a claim under section 2154, the claimant
13 may commence an action against the administrator in the Superior Court of Kennebec
14 County to establish a claim.

15 **SUBCHAPTER 10**

16 **VERIFIED REPORT OF PROPERTY; EXAMINATION OF RECORDS**

17 **§2161. Verified report of property**

18 If a person does not file a report required by section 2091 or the administrator
19 believes that a person may have filed an inaccurate, incomplete or false report, the
20 administrator may require the person to file a verified report in a form prescribed by the
21 administrator. The verified report must:

22 **1. Reportable property.** State whether the person is holding property reportable
23 under this Act;

24 **2. Describe property.** Describe property not previously reported or about which the
25 administrator has inquired;

26 **3. Specifically identify disputed property.** Specifically identify property described
27 under subsection 2 about which there is a dispute whether it is reportable under this Act;
28 and

29 **4. Amount or value.** State the amount or value of the property.

30 **§2162. Examination of records to determine compliance**

31 The administrator, at reasonable times and on reasonable notice, may:

32 **1. Examine records.** Examine the records of a person, including examination of
33 appropriate records in the possession of an agent of the person under examination, if the
34 records are reasonably necessary to determine whether the person has complied with this
35 Act;

1 **2. Issue administrative subpoena.** Issue an administrative subpoena requiring the
2 person under subsection 1 or agent of the person to make records available for
3 examination;

4 **3. Examination even if person believes not in possession.** The administrator may
5 conduct the examination under subsection 1 even if the person believes it is not in
6 possession of any property that must be reported, paid or delivered under this Act; and

7 **4. Bring enforcement action.** Bring an action seeking judicial enforcement of the
8 subpoena under subsection 2.

9 **§2163. Rules for conducting examination**

10 The administrator may adopt rules governing procedures and standards for an
11 examination under section 2162.

12 **§2164. Records obtained in examination**

13 Records obtained and records compiled, including work papers, by the administrator
14 in the course of conducting an examination under section 2162:

15 **1. Confidentiality and security provisions.** Are subject to the confidentiality and
16 security provisions of subchapter 14 and are not public records;

17 **2. Use to collect property, enforce the Act.** May be used by the administrator in an
18 action to collect property or otherwise enforce this Act;

19 **3. Use in joint examination.** May be used in a joint examination conducted with
20 another state, the United States, a foreign country or subordinate unit of a foreign
21 country, or any other governmental entity if the governmental entity conducting the
22 examination is legally bound to maintain the confidentiality and security of information
23 obtained from a person subject to examination in a manner substantially equivalent to that
24 under subchapter 14;

25 **4. Disclosure.** Must be disclosed, on request, to the person that administers the
26 unclaimed property law of another state for that state's use in circumstances equivalent to
27 circumstances described in this subchapter, if the other state is required to maintain the
28 confidentiality and security of information obtained in a manner substantially equivalent
29 to that under subchapter 14;

30 **5. Produced pursuant to subpoena.** Must be produced by the administrator under
31 an administrative or judicial subpoena or administrative or court order; and

32 **6. Produced upon request in proceeding.** Must be produced by the administrator
33 on request of the person subject to the examination in an administrative or judicial
34 proceeding relating to the property.

1 **§2165. Evidence of unpaid debt or undischarged obligation**

2 **1. Prima facie evidence of debt or obligation.** A record of a putative holder
3 showing an unpaid debt or undischarged obligation is prima facie evidence of the debt or
4 obligation.

5 **2. Preponderance of evidence.** A putative holder may establish by a preponderance
6 of the evidence that there is no unpaid debt or undischarged obligation for a debt or
7 obligation described in subsection 1 or that the debt or obligation was not, or no longer is,
8 a fixed and certain obligation of the putative holder.

9 **3. Overcome prima facie evidence.** A putative holder may overcome prima facie
10 evidence under subsection 1 by establishing by a preponderance of the evidence that a
11 check, draft or similar instrument was:

12 A. Issued as an unaccepted offer in settlement of an unliquidated amount;

13 B. Issued but later was replaced with another instrument because the earlier
14 instrument was lost or contained an error that was corrected;

15 C. Issued to a party affiliated with the issuer;

16 D. Paid, satisfied or discharged;

17 E. Issued in error;

18 F. Issued without consideration;

19 G. Issued but there was a failure of consideration;

20 H. Voided not later than 90 days after issuance for a valid business reason set forth
21 in a contemporaneous record; or

22 I. Issued but not delivered to a 3rd-party payee for a sufficient reason recorded
23 within a reasonable time after issuance.

24 **4. Evidence of course of dealing.** In asserting a defense under this section, and
25 subject to section 2094, a putative holder may present evidence of a course of dealing
26 between the putative holder and the apparent owner.

27 **§2166. Failure of person examined to retain records**

28 If a person subject to examination under section 2162 does not retain the records as
29 required by section 2094, the administrator may determine the value of property due
30 using a reasonable method of estimation based on all information available to the
31 administrator, including extrapolation and use of statistical sampling when appropriate
32 and necessary, consistent with examination procedures and standards adopted under and
33 in accordance with section 2163.

34 **§2167. Report to person whose records were examined**

35 At the conclusion of an examination under section 2162, upon request, the
36 administrator shall provide to the person whose records were examined a report that
37 specifies:

1 **1. Work performed.** The work performed;

2 **2. Property types.** The property types reviewed;

3 **3. Methodology.** The methodology of any estimation technique, extrapolation or
4 statistical sampling used in conducting the examination;

5 **4. Calculation.** Each calculation showing the value of property determined to be
6 due; and

7 **5. Findings.** The findings of the person conducting the examination.

8 **§2168. Complaint to administrator about conduct of person conducting**
9 **examination**

10 If a person subject to examination under section 2162 believes the person conducting
11 the examination has made an unreasonable or unauthorized request or is not proceeding
12 expeditiously to complete the examination, the person in a record may ask the
13 administrator to intervene and take appropriate remedial action, including
14 countermanding the request of the person conducting the examination, imposing a time
15 limit for completion of the examination or reassigning the examination to another person.
16 The administrator shall respond to all such requests within 30 days of receipt of the
17 complaint.

18 **§2169. Administrator's contract to conduct examination**

19 The administrator may contract with a person to conduct an examination under this
20 subchapter.

21 **§2170. Determination of liability for unreported reportable property**

22 If the administrator determines from an examination conducted under section 2162
23 that a putative holder failed or refused to pay or deliver to the administrator property that
24 is reportable under this Act, the administrator shall issue a determination of the putative
25 holder's liability to pay or deliver and shall give notice in a record to the putative holder
26 of the determination.

27 **SUBCHAPTER 11**

28 **DETERMINATION OF LIABILITY; PUTATIVE HOLDER REMEDIES**

29 **§2181. Informal conference**

30 **1. Request for informal conference.** Not later than 30 days after receipt of a notice
31 under section 2170, the putative holder may request an informal conference with the
32 administrator to review the determination. The holder must include in the request the
33 specific items to be discussed. Except as otherwise provided in this section, the
34 administrator may designate an employee to act on behalf of the administrator.

35 **2. Response to request for informal conference.** If a putative holder makes a
36 timely request under subsection 1 for an informal conference:

1 A. Not later than 30 days after the date of the request, the administrator shall set the
2 time and place of the conference;

3 B. The administrator shall give the putative holder notice in a record of the time and
4 place of the conference;

5 C. The conference may be held in person, by telephone or by electronic means, as
6 determined by the administrator;

7 D. The request tolls the 90-day period under sections 2183 and 2184 until notice of a
8 decision under paragraph G has been given to the putative holder or the putative
9 holder withdraws the request for the conference;

10 E. The conference may be postponed, adjourned and reconvened as the administrator
11 determines appropriate;

12 F. The administrator or administrator's designee with the approval of the
13 administrator may modify a determination made under section 2170 or withdraw the
14 determination; and

15 G. The administrator shall issue a decision in a record and provide a copy of the
16 record to the putative holder and examiner not later than 30 days after the conference
17 ends.

18 **3. Conference not administrative remedy; procedure.** A conference under
19 subsection 1 is not an administrative remedy. An oath is not required and rules of
20 evidence do not apply in the conference.

21 **4. Opportunity to confer informally.** At a conference under subsection 2, the
22 putative holder must be given an opportunity to confer informally with the administrator
23 and the person that examined the records of the putative holder to:

24 A. Discuss the determination made under section 2170; and

25 B. Present any issue concerning the validity of the determination made under section
26 2170.

27 **5. Failure to act within period.** If the administrator fails to act within the period
28 prescribed in subsection 2, paragraph A or G, the failure does not affect a right of the
29 administrator, except that interest does not accrue on the amount for which the putative
30 holder was determined to be liable under section 2170 during the period in which the
31 administrator failed to act until the earlier of:

32 A. The date under section 2183 on which the putative holder initiates administrative
33 review or the date on which the putative holder files an action under section 2184;
34 and

35 B. Ninety days after the putative holder received notice of the administrator's
36 determination under section 2170 if no review was initiated under section 2183 and
37 no action was filed under section 2184.

38 **6. Informal conference before administrative review.** The administrator may hold
39 an informal conference with a putative holder about a determination under section 2170

1 without a request at any time before the putative holder initiates administrative review
2 under section 2183 or files an action under section 2184.

3 **7. Interest and penalties.** Interest and penalties under section 2194 continue to
4 accrue on property not reported, paid or delivered as required by this Act after the
5 initiation, and during the pendency, of an informal conference under this section.

6 **§2182. Review of administrator's determination**

7 A putative holder may seek relief from a determination under section 2170 by:

8 **1. Administrative review.** Administrative review under section 2183; or

9 **2. Judicial review.** Judicial review under section 2184.

10 **§2183. Administrative review**

11 **1. Review under Maine Administrative Procedure Act.** Not later than 90 days
12 after receiving notice of the administrator's determination under section 2170, a putative
13 holder may initiate a proceeding under the Maine Administrative Procedure Act for
14 review of the administrator's determination.

15 **2. Judicial review; de novo proceeding.** A final decision in an administrative
16 proceeding initiated under subsection 1 is subject to judicial review by the Superior Court
17 as a matter of right in a de novo proceeding on the record in which either party is entitled
18 to introduce evidence as a supplement to the record.

19 **§2184. Judicial remedy**

20 **1. Action by putative holder.** Not later than 90 days after receiving notice of the
21 administrator's determination under section 2170, the putative holder may:

22 A. File an action against the administrator in the Superior Court of Kennebec County
23 challenging the administrator's determination of liability and seeking a declaration
24 that the determination is unenforceable, in whole or in part; or

25 B. Pay the amount or deliver the property determined by the administrator to be paid
26 or delivered to the administrator and, not later than 6 months after payment or
27 delivery, file an action against the administrator in the Superior Court of Kennebec
28 County for a refund of all or part of the amount paid or return of all or part of the
29 property delivered.

30 **2. Continue action.** If a putative holder pays or delivers property that the
31 administrator determined must be paid or delivered to the administrator at any time after
32 the putative holder files an action under subsection 1, paragraph A, the court shall
33 continue the action as if it had been filed originally as an action for a refund or return of
34 property under subsection 1, paragraph B.

35 **SUBCHAPTER 12**

36 **ENFORCEMENT BY ADMINISTRATOR**

1 **§2191. Judicial action to enforce liability**

2 **1. Enforcement of determination.** If a determination under section 2170 becomes
3 final and is not subject to administrative or judicial review, the administrator may
4 commence an action in the Superior Court of Kennebec County or in an appropriate court
5 of another state to enforce the determination and secure payment or delivery of past due,
6 unpaid or undeliverable property. The action must be brought not later than 5 years after
7 the determination becomes final.

8 **2. Court having jurisdiction.** In an action under subsection 1, if no court in this
9 State has jurisdiction over the defendant, the administrator may commence an action in
10 any court having jurisdiction over the defendant.

11 **§2192. Interstate and international agreement; cooperation**

12 **1. Exchange or examination.** Subject to subsection 2, the administrator may:

13 A. Exchange information with another state or foreign country relating to property
14 presumed abandoned or relating to the possible existence of property presumed
15 abandoned; and

16 B. Authorize in a record another state or foreign country or a person acting on behalf
17 of the other state or country to examine the administrator's records of a putative
18 holder as provided in subchapter 10.

19 **2. Confidentiality and security protections.** An exchange or examination under
20 subsection 1 may be done only if the state or foreign country has confidentiality and
21 security requirements substantially equivalent to those in subchapter 14 or agrees in a
22 record to be bound by this State's confidentiality and security requirements.

23 **§2193. Action involving another state or foreign country**

24 **1. Joint examination and enforcement.** The administrator may join another state
25 or foreign country to examine and seek enforcement of this Act against a putative holder.

26 **2. Action by Attorney General.** On request of another state or foreign country, the
27 Attorney General may commence an action on behalf of the other state or country to
28 enforce in this State the law of the other state or country against a putative holder subject
29 to a claim by the other state or country.

30 **3. Requested action in another state or foreign country.** The administrator may
31 request the official authorized to enforce the unclaimed property law of another state or
32 foreign country to commence an action to recover property in the other state or country
33 on behalf of the administrator. This State may pay the costs, including reasonable
34 attorney's fees and expenses, incurred by the other state or foreign country in an action
35 under this subsection.

36 **4. Recovery of property in another state.** The administrator may pursue an action
37 on behalf of this State to recover property subject to this Act but delivered to the custody
38 of another state if the administrator believes the property is subject to the custody of the
39 administrator.

1 **5. Retain an attorney.** With the consent of the Attorney General, the administrator
2 may retain an attorney in this State, another state or a foreign country to commence an
3 action to recover property on behalf of the administrator and may agree to pay attorney's
4 fees based in whole or in part on a fixed fee, hourly fee or a percentage of the amount or
5 value of property recovered in the action.

6 **6. Expenses.** Expenses incurred by this State in an action under this section may be
7 paid from property received under this Act or the net proceeds of the property. Expenses
8 paid to recover property may not be deducted from the amount that is subject to a claim
9 under this Act by the owner.

10 **§2194. Interest and penalty for failure to act in timely manner**

11 **1. Interest.** A holder that fails to report, pay or deliver property within the time
12 prescribed by this Act shall pay to the administrator interest at an annual rate of 18%, or
13 10% above the annual rate of discount in effect on the date the property should have been
14 paid or delivered for the most recent issue of 52-week United States Treasury bills, on the
15 property or value thereof from the date the property should have been reported, paid or
16 delivered.

17 **2. Civil penalty.** Except as otherwise provided in section 2195 or 2196, the
18 administrator may require a holder that fails to report, pay or deliver property within the
19 time prescribed by this Act to pay to the administrator, in addition to interest included
20 under subsection 1, a civil penalty of \$200 for each day the duty is not performed, up to a
21 cumulative maximum amount of \$5,000.

22 **§2195. Other civil penalties**

23 **1. Evading obligation or willfully failing to perform.** If a holder enters into a
24 contract or other arrangement for the purpose of evading an obligation under this Act or
25 otherwise willfully fails to perform a duty imposed on the holder under this Act, the
26 administrator may require the holder to pay the administrator, in addition to interest as
27 provided in section 2194, subsection 1, a civil penalty of \$1,000 for each day the
28 obligation is evaded or the duty is not performed, up to a cumulative maximum amount of
29 \$25,000, plus 25% of the amount or value of property that should have been but was not
30 reported, paid or delivered as a result of the evasion or failure to perform.

31 **2. Fraudulent report.** If a holder makes a fraudulent report under this Act, the
32 administrator may require the holder to pay to the administrator, in addition to interest
33 under section 2194, subsection 1, a civil penalty of \$1,000 for each day from the date the
34 report was made until corrected, up to a cumulative maximum of \$25,000, plus 25% of
35 the amount or value of any property that should have been reported but was not included
36 in the report or was underreported.

37 **3. Lack of knowledge of death.** A holder who fails to report, pay or deliver
38 property within the time prescribed by this Act is not required to pay interest under
39 section 2194, subsection 1 or subject to penalties under section 2194, subsection 2 if the
40 failure to report, pay or deliver the property was due to lack of knowledge of a death that
41 established the period of abandonment under this Act.

1 **§2196. Waiver of interest and penalty**

2 The administrator:

3 1. Waive interest and penalties. May waive, in whole or in part, interest under
4 section 2194, subsection 1 and penalties under section 2194, subsection 2 or section
5 2195; and

6 2. Good faith, without negligence. Shall waive a penalty under section 2194,
7 subsection 2 if the administrator determines that the holder acted in good faith and
8 without negligence.

9 **SUBCHAPTER 13**

10 **AGREEMENT TO LOCATE PROPERTY OF APPARENT OWNER HELD BY**
11 **ADMINISTRATOR**

12 **§2201. When agreement to locate property enforceable**

13 An agreement by an apparent owner and a professional investigator, as defined by
14 Title 32, section 8103, subsection 5, the primary purpose of which is to locate, deliver,
15 recover or assist in the location, delivery or recovery of property held by the
16 administrator, is enforceable only if the agreement:

17 1. Record. Is in a record that clearly states the nature of the property and the
18 services to be provided;

19 2. Signed. Is signed by or on behalf of the apparent owner; and

20 3. Amount or value. States the amount or known value of the property reasonably
21 expected to be recovered, computed before and after a fee or other compensation to be
22 paid to the professional investigator has been deducted.

23 **§2202. When agreement to locate property void**

24 1. Agreement void in 24-month period. Subject to subsection 2, an agreement
25 under section 2201 is void if it is entered into during the period beginning on the date the
26 property was paid or delivered by a holder to the administrator and ending 24 months
27 after the payment or delivery.

28 2. Mineral proceeds. If a provision in an agreement described in subsection 1
29 applies to mineral proceeds for which compensation is to be paid to the other person
30 based in whole or in part on a part of the underlying minerals or mineral proceeds not
31 then presumed abandoned, the provision is void regardless of when the agreement was
32 entered into.

33 3. Unconscionable amount; action to reduce amount. An agreement under
34 subsection 1 that provides for compensation in an amount that is unconscionable is
35 unenforceable except by the apparent owner. An apparent owner that believes the

1 compensation the apparent owner has agreed to pay is unconscionable may file an action
2 to reduce the compensation to the maximum amount that is not unconscionable.

3 **4. Unconscionable on other grounds.** An apparent owner or the administrator may
4 assert that an agreement described in this section is void on a ground other than it
5 provides for payment of unconscionable compensation.

6 **5. Not applicable.** This section does not apply to an apparent owner's agreement
7 with an attorney to pursue a claim for recovery of specifically identified property held by
8 the administrator or to contest the administrator's denial of a claim for recovery of the
9 property.

10 **6. Administrator provides list.** Upon request, the administrator shall provide a list
11 of unclaimed funds to a person possessing a valid professional investigator's license
12 granted under the laws of this State. The list must be compiled semiannually and must
13 contain the property identification, owner name, owner relationship, owner address,
14 holder name, property description, date received and property value. The list must
15 include all reconciled, identifiable, nontangible unclaimed properties at the time of
16 compilation that have been in the possession of the administrator for at least 24 months
17 and that have a minimum value of \$500. The administrator may charge a reasonable fee
18 to cover the costs of creating, maintaining and distributing this list.

19 SUBCHAPTER 14

20 CONFIDENTIALITY AND SECURITY OF INFORMATION

21 §2211. Definitions; applicability

22 **1. Personal information defined.** As used in this subchapter, "personal
23 information" means:

24 A. Information that identifies or reasonably can be used to identify an individual,
25 such as first and last name in combination with the individual's:

26 (1) Social security number or other government-issued number or identifier;

27 (2) Date of birth;

28 (3) Home or physical address;

29 (4) E-mail address or other online contact information or Internet protocol
30 address;

31 (5) Financial account number or credit or debit card number;

32 (6) Biometric data, health or medical data or insurance information; or

33 (7) Passwords or other credentials that permit access to an online or other
34 account;

35 B. Personally identifiable financial or insurance information, including nonpublic
36 personal information defined by applicable federal law; and

1 C. Any combination of data that, if accessed, disclosed, modified or destroyed
2 without authorization of the owner of the data or if lost or misused, would require
3 notice or reporting under Title 10, section 1348 and federal privacy and data security
4 law, whether or not the administrator or the administrator's agent is subject to the law.

5 **2. Applies to administrator's agent.** A provision of this subchapter that applies to
6 the administrator or the administrator's records applies to an administrator's agent.

7 **§2212. Confidential information**

8 **1. Confidential.** Except as otherwise provided in this Act, the following are
9 confidential and exempt from public inspection and disclosure:

10 A. Records of the administrator and the administrator's agent related to the
11 administration of this Act;

12 B. Reports and records of a holder in the possession of the administrator or the
13 administrator's agent;

14 C. Personal information and other information derived or otherwise obtained by or
15 communicated to the administrator or the administrator's agent from an examination
16 under this Act of the records of a person; and

17 D. The identity of a person subject to an examination under section 2162.

18 **2. Continues to be confidential.** A record or other information that is confidential
19 under the laws of this State other than this Act, of another state or of the United States
20 continues to be confidential when disclosed or delivered under this Act to the
21 administrator or administrator's agent.

22 **§2213. When confidential information may be disclosed**

23 **1. To enforce or implement Act.** When reasonably necessary to enforce or
24 implement this Act, the administrator may disclose confidential information concerning
25 property held by the administrator or the administrator's agent only to:

26 A. An apparent owner or the apparent owner's attorney, other legal representative or
27 relative;

28 B. The personal representative, executor, other legal representative or relative of a
29 deceased apparent owner or a person entitled to inherit from a deceased apparent
30 owner;

31 C. Another department or agency of this State or the United States;

32 D. The person that administers the unclaimed property law of another state, if the
33 other state accords substantially reciprocal privileges to the administrator and if the
34 other state is required to maintain the confidentiality and security of obtained
35 information in a manner substantially equivalent to that under this subchapter; or

36 E. Pursuant to section 2164, subsection 6, the person subject to an examination.

37 **2. Name of apparent owners; additional information.** Except as otherwise
38 provided in section 2212, subsection 1, the administrator shall include on the website

1 required by section 2103, subsection 1 the name of each apparent owner of property held
2 by the administrator. The administrator may include in published notices, printed
3 publications, telecommunications, the Internet or other media and on the website or in the
4 database additional information concerning the apparent owner's property if the
5 administrator believes the information will assist in identifying and returning property to
6 the owner and does not disclose personal information except the home or physical
7 address of an apparent owner.

8 **3. No use of confidential information; exception.** The administrator and the
9 administrator's agent may not use confidential information provided to them or in their
10 possession except as expressly authorized by this Act or required by law other than this
11 Act.

12 **§2214. Confidentiality agreement**

13 A person to be examined under section 2162 may require, as a condition of disclosure
14 of the records of the person to be examined, that the administrator or the administrator's
15 agent execute and deliver to the person to be examined a confidentiality agreement that:

16 **1. Form.** Is in a form that is reasonably satisfactory to the administrator; and

17 **2. Compliance with subchapter.** Requires the person having access to the records
18 to comply with the provisions of this subchapter applicable to the person.

19 **§2215. Security breach**

20 **1. Notice to holder.** Except to the extent prohibited by law other than this Act, the
21 administrator or administrator's agent shall notify a holder as soon as practicable of:

22 **A.** A suspected loss, misuse or unauthorized access, disclosure, modification or
23 destruction of confidential information obtained from the holder in the possession of
24 the administrator or an administrator's agent; and

25 **B.** Any interference with operations in any system hosting or housing confidential
26 information that:

27 (1) Compromises the security, confidentiality or integrity of the information; or

28 (2) Creates a substantial risk of identity fraud or theft.

29 **2. Disclosure of breach limited.** Except as necessary to inform an insurer, attorney,
30 investigator or others as required by law, the administrator and an administrator's agent
31 may not disclose, without the express consent in a record of the holder, an event
32 described in subsection 1 to a person whose confidential information was supplied by the
33 holder.

34 **3. Action of administrator and administrator's agent.** If an event described in
35 subsection 1 occurs, the administrator and the administrator's agent shall:

36 **A.** Take action necessary for the holder to understand and minimize the effect of the
37 event and determine its scope; and

1 B. Cooperate with the holder with respect to:

2 (1) Any notification required by law concerning a data or other security breach;
3 and

4 (2) A regulatory inquiry, litigation or similar action.

5 **§2216. Indemnification for breach**

6 **1. Indemnification of holder by State.** If a claim is made or action commenced
7 arising out of an event described in section 2215, subsection 1 relating to confidential
8 information possessed by the administrator, this State shall indemnify, defend and hold
9 harmless a holder and the holder's affiliates, officers, directors, employees and agents as
10 to:

11 A. Any claim or action; and

12 B. A liability, obligation, loss, damage, cost, fee, penalty, fine, settlement, charge or
13 other expense, including reasonable attorney's fees and costs, established by the claim
14 or action.

15 **2. Indemnification by administrator's agent.** If a claim is made or action
16 commenced arising out of an event described in section 2215, subsection 1 relating to
17 confidential information possessed by an administrator's agent, the administrator's agent
18 shall indemnify, defend and hold harmless a holder and the holder's affiliates, officers,
19 directors, employees and agents as to:

20 A. Any claim or action; and

21 B. A liability, obligation, loss, damage, cost, fee, penalty, fine, settlement, charge or
22 other expense, including reasonable attorney's fees and costs, established by the claim
23 or action.

24 **3. Insurance for indemnification.** The administrator shall require an
25 administrator's agent that will receive confidential information required under this Act to
26 maintain adequate insurance for indemnification obligations of the administrator's agent
27 under subsection 2. The administrator's agent required to maintain the insurance shall
28 provide evidence of the insurance to:

29 A. The administrator not less frequently than annually; and

30 B. The holder on commencement of an examination and annually thereafter until all
31 confidential information is returned or destroyed by the administrator or the
32 administrator's agent because the confidential information is no longer reasonably
33 needed under this Act.

34 **SUBCHAPTER 15**

35 **MISCELLANEOUS PROVISIONS**

36 **§2221. Relation to Electronic Signatures in Global and National Commerce Act**

37 This Act modifies, limits and supersedes the federal Electronic Signatures in Global
38 and National Commerce Act, 15 United States Code, Section 7001 et seq., but does not

1 modify, limit or supersede Section 101(c) of that Act, 15 United States Code, Section
2 7001(c), or authorize electronic delivery of any of the notices described in Section 103(b)
3 of that Act, 15 United States Code, Section 7003(b).

4 **§2222. Transitional provision**

5 **1. Initial report, 10-year period preceding October 1, 2019.** An initial report filed
6 under this Act for property that was not required to be reported before October 1, 2019
7 but that is required to be reported under this Act, must include all items of property that
8 would have been presumed abandoned during the 10-year period preceding October 1,
9 2019 as if this Act had been in effect during that period.

10 **2. Duty before October 1, 2019 continues.** This Act does not relieve a holder of a
11 duty that arose before October 1, 2019 to report, pay or deliver property. Subject to
12 section 2120, subsection 2, a holder that did not comply with the law governing
13 unclaimed property before October 1, 2019 is subject to applicable provisions for
14 enforcement and penalties in effect before October 1, 2019.

15 **§2223. Effective date**

16 This Act takes effect October 1, 2019.
