1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 22 MRSA §50**, as enacted by PL 2009, c. 279, §1, is amended to read:

3 **§50. Planning for long-term care services**

4 By January 15, ~~2012~~ 2021 and every 4 years thereafter the department, after input
5 from interested parties, shall report to the joint standing committee of the Legislature
6 having jurisdiction over health and human services matters on the current allocation of
7 resources for long-term care and the goals for allocation of those resources during the
8 next 4 years. The report must be based on current and projected demographic data,
9 current and projected consumer needs and recent or anticipated changes in methods of
10 delivery of long-term care services and must include any action taken by the department,
11 both at the state and federal level, to further these goals and any recommendations for
12 action by the Legislature. The report must also include a description of the activities and
13 any recommendations of the quality assurance review committee established pursuant to
14 section 5107-I.

15 **Sec. 2. 22 MRSA §5106, sub-§3, ¶A**, as amended by PL 2011, c. 657, Pt. BB,
16 §9, is repealed.

17 **Sec. 3. 22 MRSA §5107-I, sub-§4**, as amended by PL 2011, c. 495, §2, is
18 repealed.

19 **Sec. 4. 22-A MRSA §206, sub-§9**, as enacted by PL 2017, c. 284, Pt.
20 NNNNNNN, §17, is repealed.

21 **SUMMARY**

22 This bill consolidates reporting requirements regarding Department of Health and
23 Human Services planning for and activities concerning the State's aging population and
24 incapacitated and dependent adults and the department's quality assurance review
25 committee's recommendations and activities. It also repeals requirements for annual
26 press releases and reports by the Commissioner of Health and Human Services regarding
27 department spending, welfare fraud-related statistics, contracting services, grants received
28 from the Federal Government and total out-of-state travel costs for employees.
