16	Amend the resolve in the preamble by inserting after the 5th paragraph the following:
17 18 19	'Whereas, the Department of Transportation received letters of support from communities along the section of the state-owned rail corridor known as the Calais Branch requesting the formation of a rail corridor use advisory council; and
20 21	Whereas, the Calais Branch Rail Use Advisory Council convened and met over a period of 8 months in 2024; and
22 23 24	Whereas, 10 of the 11 Calais Branch Rail Use Advisory Council members, with one member abstaining, voted to recommend the interim conversion of the existing railroad track to a multi-use trail; and

pursuant to the Maine Revised Statutes, Title 23, section 7107, the Department of Transportation shall remove 12.26 miles of state-owned inactive existing railroad track along the section known as the Calais Branch from the Route 214 intersection in Ayers Junction in the Town of Pembroke to Route 1 in the City of Calais and replace the track with a multi-use trail on the existing rail bed. The completed multi-use trail is interim in nature, and the project to create the multi-use trail is subject to available funding resources, permitting and municipal agreements.'

Fiscal Detail and Notes

This bill requires the Department of Transportation, subject to available funding, permitting and municipal agreements, to remove 12.26 miles of inactive track material from the Route 214 intersection in Ayers Junction in Pembroke to Route 1 in Calais and replace the track with a multi-use trail. It also requires the Department, subject to funding, permitting and municipal agreements, to remove inactive railroad track along the section known as the Lower Road between the Town of Brunswick and the City of Hallowell and replace the track with an interim bicycle and pedestrian trail. Currently no funding exists for these purposes.
