Except as provided in section 6575-L, a person issued a license under this section or section 6302-A, subsection 3, paragraph E, E-1, F or G may not take, possess or sell elvers in excess of the weight quota allocated to that person under the quota system. The rules must:</u>

amount of elvers a person licensed under this section lawfully harvested in previous seasons based on final harvesting reports. The rules must specify the date by which harvester reports are considered final for the purpose of determining individual quotas; and

5 C. Provide, in accordance with section 6302-B, that 21.9% of the overall annual quota 6 under paragraph A is allocated to the federally recognized Indian tribes in the State and 7 establish the amount of that portion of the overall annual quota allocated to the 8 Passamaquoddy Tribe, the Penobscot Nation, the Houlton Band of Maliseet Indians 9 and the Mi'kmaq Nation.

10 If persons issued licenses under this section collectively exceed the overall annual quota allocated to those persons pursuant to paragraph B, the number of pounds by which the 11 12 license holders exceeded that overall annual quota must be deducted from the following 13 year's overall annual quota allocated to persons licensed under this section. If the overage 14 exceeds the overall annual quota allocated to persons licensed under this section for the 15 following year, the overage must be deducted from the overall annual quota allocated to 16 persons licensed under this section in subsequent years until the entire overage has been 17 accounted for.

The commissioner may adopt or amend rules on an emergency basis if immediate action is
necessary to establish and implement the elver individual fishing quota in advance of the
beginning of the elver fishing season.

Rules adopted pursuant to this subsection are routine technical rules as defined in Title 5,
chapter 375, subchapter 2-A.

24 §6505-E. Elver handling training course

Prior to the issuance of an elver fishing license, the commissioner may require an
applicant to complete an educational course that the commissioner determines appropriate
to provide necessary information regarding the proper handling of elvers to ensure
survivability.'

Amend the bill by striking out all of the emergency clause.

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section
number to read consecutively.

SUMMARY

This amendment removes the emergency preamble and emergency clause from the bill. The amendment allows the Commissioner of Marine Resources to require certain applicants for an elver fishing license to complete an educational course and gives the commissioner the authority to withhold up to 1% of the available overall annual elver quota for the State before allocating any portion of the overall annual quota. The amendment also removes limits on possession of elvers established by the bill and removes the changes regarding the suspension of a license or certificate made by the bill.

40 The amendment also removes from the bill the provision permitting an elver fishing 41 license holder to whom a fyke net tag is issued to allow another license holder to empty the 42 fyke net of the tag holder under the tag holder's supervision.
