Department of Inland Fisheries and Wildlife to study establishing 17 program for electronic tagging of deer. Resolved: That the Department of Inland Fisheries and Wildlife shall study and establish a plan for the implementation of a program 18 19 for the electronic tagging of harvested deer. The department shall submit a report, including suggested legislation, to the Joint Standing Committee on Inland Fisheries and Wildlife no 20 21 later than January 14, 2026. The report must include information on the projected costs, 22 programming and staffing requirements of developing and implementing an electronic 23 tagging program and how the department would recoup lost money, if applicable. To the 24 extent practicable, the department shall consult with local business owners in the study who 25 contract as registered agents of the department for the tagging of deer to gauge how a 26 transition to an electronic tagging program may impact these agents, especially in more 27 rural areas of the State. The report must also include information related to anticipated 28 effects on biological data collection and relevant compliance and enforcement issues. 29 Finally, the report must outline a plan for program implementation, including suggested 30 time frames, and a plan for how the department would raise awareness of an electronic 31 tagging program across the State. The Joint Standing Committee on Inland Fisheries and 32 Wildlife may report out a bill based on the report to the Second Regular Session of the 33 132nd Legislature.' 34 Amend the resolve by relettering or renumbering any nonconsecutive Part letter or 35 section number to read consecutively.

This amendment replaces the resolve and changes the title. Whereas the resolve directs the Department of Inland Fisheries and Wildlife to establish a program for the electronic tagging of deer and report back to the Joint Standing Committee on Inland Fisheries and Wildlife no later than December 3, 2025, the amendment directs the department to study and establish a plan for such a program and report back to the committee no later than January 14, 2026. The committee is authorized to report out a bill based on the report to the Second Regular Session of the 132nd Legislature.
