Emergency contact information; implementation by Secretary of 23 State. The Department of the Secretary of State shall begin issuing certificates of 24 registration that comply with this Act when the Department of the Secretary of State 25 replaces its stock of certificates of registration.' 26.

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

This amendment requires the Secretary of State to provide a blank space on the reverse side of a motor vehicle certificate of registration that allows the registered owner to voluntarily provide the legal name and address of an emergency contact. The Department of the Secretary of State is required to begin issuing certificates of registration with space
