The fee for a duplicate license or duplicate nondriver identification card under section 1260 is \$30. The fee for the expedited issuance of a duplicate license or nondriver identification card including the expedited issuance of a duplicate license or nondriver identification card under section 1260, is an additional \$10. The reason for the expedited issuance must be provided, and the Secretary of State shall determine if expedited issuance is warranted.

This bill repeals the law that permits the Secretary of State, upon request of an applicant, to issue a driver's license or a nondriver identification card that meets the standards of the federal REAL ID Act of 2005, Public Law 109-13. The bill also repeals provisions of law that concern fees for REAL ID licenses and identification cards.
