COMMITTEE AMENDMENT "A" to H.P. 120, L.D. 187, "An Act to Prohibit Labor Organizations from Imposing Mandatory Service Fees on Nonmembers"

Amend the bill by striking out the title and substituting the following:

'An Act to Prohibit Public Labor Organizations from Imposing Mandatory Service Fees on Nonmembers'

Amend the bill by striking out all of section 1.

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

This amendment changes the title and removes the provision of the bill that provides that an employee in the private sector who has refrained from joining or participating in a union may not be required to pay to the organization that is the bargaining agent for the employee a service fee that represents that employee's pro rata share of those expenditures that are germane to the organization's representational activities.

Fiscal Detail and Notes

This legislation may increase litigation before the Maine Labor Relations Board, resulting in increased payments to board members for per diem and other expenses. Pursuant to Title 26, section 968, per diem and necessary expense for members and alternates of the board, as well as state cost allocation program charges, must be shared equally by the parties to any proceeding at which the board presides and must be paid into a special fund administered by the board from which all costs must be paid.
