12 13	Amend the bill in section 5 in §6313 by striking out all of subsection 3 (page 2, lines 3 to 5 in L.D.) and inserting the following:
14 15 16 17	'3. Agent fees. A fee may not be charged for a for-hire charter boat operator's license under this section. A person seeking a license through an agent may be charged an agent fee of \$2. A person seeking a license through a publicly accessible online electronic system for licensing may be charged an agent fee of \$1. A person seeking a license at an office of the department from a department employee may be charged an agent fee of \$1.
19 20	Amend the bill in section 5 in §6313 in subsection 4 by striking out all of paragraph A (page 2, lines 9 and 10 in L.D.) and inserting the following:
21 22 23	'A. Possesses a valid United States merchant marine document issued by the United States Coast Guard for an operator of uninspected passenger vessel or master or mate captain's license; or'
24	Amend the bill by inserting after section 5 the following:
25	'Sec. 6. Effective date. This Act takes effect January 1, 2026.'
26 27	Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
28	SUMMARY
29	This amendment makes the following changes to the bill.
30 31	1. It removes the license fee for a for-hire charter boat operator's license from the bill and replaces it with an agent fee.
32	2. It corrects language referencing the United States Coast Guard.
