SUMMARY

This amendment, which is the majority report of the committee, changes references to cyberattacks targeting state technology infrastructure, systems, services and critical infrastructure to more broadly include such attacks that affect the State. It also removes the requirement for a cyberattack to be in furtherance of political or social objectives to be considered terrorism and makes other technical changes.
