1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 34-A MRSA §3053 is enacted to read:
3	§3053. Transitional housing program and fund
4 5 6 7	<b>1. Transitional housing program.</b> The department, in collaboration with the Maine State Housing Authority, shall administer a program to provide transitional housing to an indigent client for the first 2 months after the client's release from a correctional facility. Criteria for housing under this section include that:
8 9 10	A. The housing is maintained in a safe, sanitary manner and meets all state and local building codes under Title 10, chapter 1103 and fire and life safety codes under Title 25, section 2452 for the type of building in which the transitional housing is located;
11 12 13	B. The former client has a bed and adequate bedroom and living space and the housing has private toilet and bathing facilities and adequate dining and kitchen facilities for the number of residents in the unit or building; and
14 15 16	C. Adequate provisions have been made for a former client convicted of a sex offense under Title 17-A, chapters 11 and 12 and to meet all requirements and restrictions for sex offenders under chapters 15 and 17.
17 18 19 20 21 22 23	<b>2. Transitional housing fund.</b> The transitional housing fund is established. The fund is administered by the department. The purpose of the fund is to support transitional housing for recently released clients of a correctional facility under subsection 1. The fund receives money from appropriations, allocations, donations, grants and other public and private funding sources. The department may invest money in the fund, and interest earned by the fund is credited to the fund. The fund may not lapse but must be carried forward to the next fiscal year.

The Maine State Housing Authority, in collaboration with the Department of Corrections, shall study long-term solutions for transitional housing for recently released indigent clients of the Department of Corrections. By December 3, 2025, the Maine State Housing Authority shall submit a report on the conclusions of the study, along with any recommended legislation, to the Joint Standing Committee on Housing and Economic Development. The joint standing committee may report out legislation based upon the report to the Second Regular Session of the 132nd Legislature.
