13 14	Amend the amendment by striking out all of the 2nd instructional paragraph (page 1, lines 13 to 15 in amendment) and inserting the following:
15 16	'Amend the bill in section 2 in subsection 8 by striking out all of paragraph E-1 (page 2, lines 42 to 44 in L.D.) and inserting the following:
17 18 19	'E-1. A municipal timber harvesting ordinance adopted after January 1, 2026 takes effect only after certification by the bureau that the municipality adopted the timber harvesting ordinance in accordance with the process requirements of this subsection.'
20 21	Amend the amendment by striking out all of the 4th instructional paragraph (page 1, lines 18 to 20 in amendment).
22 23	Amend the amendment by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
24	SUMMARY
25	This amendment amends Committee Amendment "A" to remove from the bill the
26	change to the definition of "timber harvesting activities." It allows timber harvesting
27	ordinances adopted after January 1, 2026 to take effect only after certification by the
28	Department of Agriculture, Conservation and Forestry, Bureau of Forestry. It also removes
29 30	from the committee amendment an instruction to change the process for the clerk of a municipality to notify the bureau of a timber harvesting ordinance.
