Material irregularities in signatures on petitions; notification. If the signature 18 of a registered voter on a petition under section 335, 354 or 902 does not match the 19 signature for that registered voter in the central voter registration system and results in that 20 registered voter's signature being invalidated, the registrar shall notify the registered voter 21 and provide the registered voter with information on how to update the registered voter's 22 signature in the central voter registration system. 23 Amend the bill by relettering or renumbering any nonconsecutive Part letter or section 24 number to read consecutively. 25 SUMMARY 26 This amendment replaces the bill and changes the title. The amendment requires a 27 registrar to notify a registered voter when a signature made by the registered voter on a 28 primary petition, nomination petition or petition to initiate proceedings for a people's veto 29 referendum or the direct initiative of legislation does not match the signature of the 30 registered voter in the central voter registration system. The registrar must provide the 31 registered voter with information on how to update the registered voter's signature in the 32 central voter registration system. 33 The preliminary fiscal impact statement identified a potential unfunded state mandate 34 in the requirements that registrars notify voters whose signatures on a petition do not match Page 1 - 132LR0456(02)

the signatures in the central voter registration system and to provide the voters with information on updating their signature in the central voter registration system.

The committee members who voted in favor of this report reviewed the preliminary fiscal impact statement and determined that because the impact on municipalities is anticipated to be insignificant statewide and that the frequency of such an event occurring is likely to be low the requirement likely will not have significant costs and does not require an expansion or modification of activities so as to necessitate additional expenditures.

### **Fiscal Note**

Potential State Mandate Removed - Committee Exception

### Fiscal Detail and Notes

In the Preliminary Fiscal Impact Statement (PFIS) for this bill, it was identified as a Potential State Mandate -Unfunded. The committee reviewed the PFIS and determined that because the likelihood of the signatures not matching between the petition and the central voter registration system would be so infrequent and the requirement likely will not have significant costs and doesn't require an expansion or modification of activities so as to necessitate additional expenditures, that this bill was not a mandate. As the committee included this exception in the summary of the committee amendment, the Potential State Mandate - Unfunded language was removed from the fiscal note for the committee amendment.
