A certified applicator as defined under the Maine Revise Statutes, Title 22, section 1471-C, subsection 4 is exempt from the prohibition under the section. The board shall submit a report with an update on the prohibition under this section to the Joint Standing Committee on Agriculture, Conservation and Forestry no later the January 15, 2026. The joint standing committee may submit a bill to the Second Regul Session of the 132nd Legislature relating to the subject matter of the report.'

27 28 29 30 31 32 33 34	This amendment replaces the bill with a resolve and removes the emergency preamb and emergency clause. The resolve requires the Department of Agriculture, Conservation and Forestry, Board of Pesticides Control to prohibit the use of rodenticides, including rodenticidal baits, in outdoor residential settings. A person who is certified by the boar pursuant to the Maine Revised Statutes, Title 22, section 1471-D and authorized to use supervise the use of any pesticides is exempt from the prohibition on the use of rodenticid in outdoor residential settings. The amendment requires the board to submit a report with an update on the prohibition on the use of rodenticides in outdoor residential settings to the

Fiscal Detail and Notes

This bill prohibits the use of rodenticides in outdoor residential settings unless applied by a licensed applicator. Approximately 117 rodenticides are currently registered for household use with the Board of Pesticides Control within the Department of Agriculture, Conservation and Forestry. If manufacturers choose not to renew product registrations due to the restricted use, Other Special Revenue Funds revenue to the department could decrease by up to \$25,155 annually.
