24 25 26 27 28 29	This amendment, which is the minority report of the committee, clarifies that the State, its political subdivisions and all governmental entities may not infringe on the authority of parents to direct the upbringing, education and care for the physical, mental and spiritual health of their children unless the infringement is narrowly tailored to achieve a compelling state interest, including the State's compelling interest in the prevention of child abuse or neglect, the prevention of criminal conduct by minors and the rehabilitation of minors who have been found to have committed criminal conduct.
