Sec. 1. 4 MRSA §1051, as repealed and replaced by PL 2021, c. 676, Pt. A, §2, is
 amended to read:

4 §1051. Legal holidays

5 Court may not be held on Sunday or any day designated for the annual Thanksgiving; Eid al-Fitr, as designated by the Governor under Title 5, section 60; Eid al-Adha, as 6 7 designated by the Governor under Title 5, section 61; New Year's Day, January 1st; Martin Luther King, Jr., Day, the 3rd Monday in January; Washington's Birthday, the 3rd Monday 8 9 in February; Patriot's Day, the 3rd Monday in April; Memorial Day, the last Monday in 10 May, but if the Federal Government designates May 30th as the date for observance of Memorial Day, the 30th of May; Juneteenth, June 19th; the 4th of July; Labor Day, the first 11 Monday of September; Indigenous Peoples Day, the 2nd Monday in October; Veterans 12 13 Day, November 11th; or on Christmas Day. The Chief Justice of the Supreme Judicial 14 Court may order that court be held on a legal holiday when the Chief Justice finds that the interests of justice and judicial economy in any particular case will be served. The public 15 16 offices in county buildings may be closed to business on the holidays named in this section. When any one of the holidays named in this section falls on Sunday, the Monday following 17 must be observed as a holiday, with all the privileges applying to any of the days named in 18 19 this section.
