

Fiscal Detail and Notes

This amendment converts the ongoing General Fund appropriations to the Maine Multicultural Center in Bangor from ongoing appropriations beginning in fiscal year 2025-26 to one-time appropriations in fiscal year 2026-27 only and reduces the funding from \$190,000 to \$47,000.
