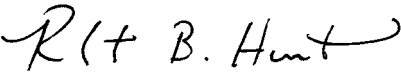

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 24-A MRSA §601, sub-§5, ¶F**, as amended by PL 2011, c. 238, Pt. H, §1,
3 is further amended by amending the 2nd blocked paragraph to read:

4 Biennial fee for appointment, each insurer, health maintenance organization, fraternal
5 benefit society, nonprofit hospital or medical service organization, viatical settlement
6 provider or risk retention group, \$30; ~~and~~

7 **Sec. 2. 24-A MRSA §601, sub-§5, ¶G**, as amended by PL 2011, c. 238, Pt. H, §2,
8 is further amended by amending the 2nd blocked paragraph to read:

9 Biennial fee for appointment, each insurer, health maintenance organization, fraternal
