1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 30-A MRSA c. 201, sub-c. 15 is enacted to read:
3	SUBCHAPTER 15
4	WEATHERIZATION PLUS PROGRAM
5	§4994-C. Weatherization Plus Program
6 7 8 9	1. Program established. The Weatherization Plus Program, referred to in this subchapter as "the program," is established within the Maine State Housing Authority, for the purposes described in subsection 2. The program must be operated in conjunction with other programs of the authority.
10	2. Purposes of program. The purposes of the program are to:
11 12 13 14	A. Help eligible low-income households implement energy conservation measures through grants and the funding of weatherization readiness or weatherization projects. For the purposes of this subchapter, "weatherization readiness" means the process to protect a building from the outside weather elements and improve its energy efficiency;
15 16 17	B. Reduce the number of deferrals from the Weatherization Assistance for Low-income Persons Program administered through the United States Department of Energy and referenced in section 4741, subsection 15; and
18 19	C. Maximize the use of federal funding available for the purposes in paragraphs A and B.
20 21 22	3. Program requirements. The Maine State Housing Authority shall establish program requirements, including, but not limited to, requiring that an applicant for the program:
23 24 25 26	A. Meet the same household income eligibility requirements applicable to the Weatherization Assistance for Low-income Persons Program administered through the United States Department of Energy and implemented pursuant to section 4741, subsection 15;
27 28 29	B. Demonstrate the dwelling for which the funds are to be applied is a single-family house or manufactured housing occupied by the applicant or another eligible low-income household; and
30 31 32	C. For weatherization readiness projects, provide a substantiated expectation of the dwelling being weatherized following completion of the weatherization readiness project.
33	An approved applicant may be awarded a grant of up to \$20,000.
34	§4994-D. Weatherization Plus Fund
35 36 37	The Weatherization Plus Fund, referred to in this subchapter as "the fund," is established under the jurisdiction and control of the Maine State Housing Authority for the purpose of providing funds for the program.
38	<b>1. Sources of fund.</b> Sources of the fund include:

A. All money appropriated for inclusion in the fund; 1 2 B. Subject to any pledge, contract or other obligation, any money that the Maine State Housing Authority receives in repayment of advances from the fund; 3 4 C. Subject to any pledge, contract or other obligation, all interest, dividends and pecuniary gains from investment of money of the fund; and 5 6 D. Any other money available to and directed by the Maine State Housing Authority to be paid into the fund. 7 8 2. Revolving fund. The fund is a nonlapsing, revolving fund. The Maine State Housing Authority shall continuously apply all money in the fund to carry out the purposes 9 10 of this subchapter. 11 Sec. 2. Appropriations and allocations.
