'Sec. 4. Department of Professional and Financial Regulation; rules. The Department of Professional and Financial Regulation shall adopt rules to establish a method for determining the net worth of an entity, together with affiliated and related entities, claiming an exemption from the fees required by the Maine Revised Statutes, Title 10, section 9090-A, subsection 1 and 9094-B, subsection 1. The rules must include the evidence and documentation necessary for a purchaser of a manufactured housing community or a mobile home park to provide to the register of deeds when offering a deed for recordation and the record-keeping obligations of the register of deeds. When developing rules, the department shall consider whether information on the incorporation of the entity is useful. Rules adopted pursuant to this section are routine technical rules as

SUMMARY

This amendment amends Committee Amendment "A" and removes the January 1, 2026 start date. It clarifies that an entity claiming an exemption from the fee based on the entity's net worth includes the net worth of affiliated and related entities. It adds a requirement that a purchaser claiming an exemption from the fee based on net worth must provide the register of deeds with an attestation of the entity's net worth at the time the deed for the manufactured housing community or mobile home park is offered for recordation. It requires the Department of Professional and Financial Regulation to adopt rules to establish the method and required evidence and documentation for a purchaser claiming an exemption to the fee to provide to the register of deeds. It requires the State Controller,
