15 16	1. Prohibited acts. It is unlawful for any person whose license or right to obtain a license is under suspension to:
17	A. Engage in any licensed activity;
18 19 20	B. Give another person permission to raise, lift, transfer or possess lobster traps or cars marked with the suspended person's lobster and crab fishing license number or lobster traps with buoys that carry the color design on file with the suspended license;
21	C. Assist a holder of a Class II lobster and crab fishing license as a crew member; or
22 23 24	E. For any violation occurring on or after the effective date of this paragraph, assist any license holder as a crew member in any activity authorized by the suspended license; or
25 26 27	F. Hold a direct and substantial financial interest in any business that buys, possesses, transports or sells elvers if that person has had that person's license or right to obtain a license issued under section 6864 suspended or revoked.'
28 29	Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
