1 **Emergency preamble.** Whereas, acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and 3 Whereas, it is anticipated that federal grants to the Department of Health and Human Services from the United States Department of Justice, Office of Justice Programs, Office 4 5 for Victims of Crime may soon be reduced; and 6 Whereas, in order to offset the loss of those federal grants, it is important that the State provide funds as soon as possible; and 7 8 Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as 9 immediately necessary for the preservation of the public peace, health and safety; now, 10 11 therefore, 12 Be it enacted by the People of the State of Maine as follows: Sec. 1. 5 MRSA §1591, sub-§2, ¶J, as amended by PL 2023, c. 412, Pt. MMMM, 13 §2, is further amended to read: 14 15 J. Any balance remaining in the Office of Behavioral Health program, General Fund account at the end of any fiscal year to be carried forward for use by this program in 16 the next fiscal year; and 17 18 Sec. 2. 5 MRSA §1591, sub-§2, ¶K, as enacted by PL 2023, c. 412, Pt. MMMM, 19 §3, is amended to read: 20 K. Any balance remaining in the Drinking Water Enforcement program, General Fund 21 account at the end of any fiscal year to be carried forward for use by this program in 22 the next fiscal year for the same purpose-; and Sec. 3. 5 MRSA §1591, sub-§2, ¶L is enacted to read: 23 24 L. Any balance remaining in the accounts of the Department of Health and Human 25 Services appropriated for the purpose of supplementing grants to the department under the federal victim assistance formula grant program administered by the United States 26 Department of Justice, Office of Justice Programs, Office for Victims of Crime 27 28 pursuant to the federal Victims of Crime Act of 1984 at the end of any fiscal year to be 29 carried forward for use in the next fiscal year for the same purpose.
