Property that a state, federal, municipal or other governmental entity has determined 12 is surplus or that it does not have the capacity to redevelop; and' 13 Amend the bill by relettering or renumbering any nonconsecutive Part letter or section 14 number to read consecutively. 15 **SUMMARY** 16 This amendment authorizes the Department of Administrative and Financial Services, 17 through the Bureau of General Services, to annually inventory all land owned by state 18 agencies and semiautonomous state agencies. It requires the department to annually send 19 the inventory to the Maine Redevelopment Land Bank Authority and the joint standing
