COMMITTEE AMENDMENT " A" 10 S.P. 482, L.D. 1193 (5-286)

Amend the bill in section 7 in the first indented paragraph in the 7th line (page 2, line 1 in L.D.) by striking out the following: "and the vote" and inserting the following: 'and, notwithstanding any provision of law to the contrary, the vote'

Amend the bill in section 7 in the first indented paragraph in the 8th line (page 2, line 2 in L.D.) by inserting after the following: "inspection" the following: 'in such a manner that it is clear how each individual member voted'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

This amendment, which is the majority report of the committee, amends the bill by specifying that conventions held by the Legislature to elect the Secretary of State, the Treasurer of State, the Attorney General and the State Auditor must be open to the public and, notwithstanding any provision of law to the contrary, the vote of each voting Senator and Representative must be recorded and made available for public inspection in such a manner that it is clear how each individual member voted.
