19 20 21 22 23	For a licensed hydropower project seeking relicensing or license surrender with the Federal Energy Regulatory Commission, the department, based on information provided by the owner or operator of the project and any other available information, shall review the project to determine the environmental, energy and public benefits of the relicensing or continued operation of the project based on the following considerations:

Whether the relicensing or continued operation of the hydropower project will result in significant environmental and energy benefits to the public, including, but not limited to, public rights of access to and use of the surface waters of the State for navigation, fishing, fowling, recreation and other lawful public uses; flood control benefits or flood hazards; and hydroelectric energy benefits, including the maintenance of or increase in generating capacity and annual energy output resulting from the project; and
31 32 33	2. Public benefits. Whether the relicensing or continued operation of the hydropower project will result in significant economic benefits to the public, including, but not limited to, maintenance or creation of employment opportunities for residents of the State.

6	SUMMARY
7	This amendment, which is the minority report of the committee, replaces the bill and
8	changes the title. It requires the Department of Environmental Protection, for a licensed
9	hydropower project seeking relicensing or license surrender with the Federal Energy
10	Regulatory Commission, to review the project to determine the environmental, energy and
11	public benefits of the relicensing or continued operation of the project based on certain
12	considerations. After conducting the review, the department must issue a written finding
13	of fact with respect to the nature and magnitude of the benefits of the relicensing or
14	continued operation of the hydropower project addressing those environmental, energy and
15	public benefits considerations and provide a copy of the written finding of fact to the owner
16	or operator of the project and to the Federal Energy Regulatory Commission.

## Fiscal Detail and Notes

This bill adds new review criteria for the Department of Environmental Protection (DEP) to consider when an existing hydropower project seeks relicensing or license surrender through the Federal Energy Regulatory Commission. The DEP has indicated that it cannot conduct these additional reviews within existing staffing and resources. Due to the intermittent nature of such reviews, the department anticipates using contracted services when the new criteria are triggered. The cost of each contracted review is estimated at approximately \$100,000.
