COMMITTEE AMENDMENT "A" to S.P. 508, L.D. 1219, "An Act to Increase State Funding for the Campuses of the University of Maine System and to Raise the Minimum Hourly Wage for Employees of the System"

Amend the bill by striking out the title and substituting the following:

'An Act to Increase State Funding for the Campuses of the University of Maine System'

Amend the bill by striking out all of the emergency preamble.

Amend the bill by striking out everything after the enacting clause and inserting the following:

'Sec. 1. Appropriations and allocations. The following appropriations and allocations are made.

Educational and General Activities - UMS 0031

Initiative: Provides ongoing funds to support a 4% increase in funding for fiscal year 2025-26 and an additional 4% increase in funding for fiscal year 2026-27 to support the continuation of current University of Maine System operations.
