DEPARTMENT TOTAL - ALL FUNDS

This bill adds renovating school kitchens and cafeterias and replacing or adding kitchen equipment to facilitate the serving of meals to students to the purposes of the School Revolving Renovation Fund. The bill also removes from the School Meal Equipment and Program Improvement Fund reimbursement for food costs related to medically necessary dietary restrictions of students from the approved uses of grants provided by that fund. The bill also provides appropriations and allocations to the School Meal Equipment and Program Improvement Fund.
