13 14 15	4-A. Board of Certification for the Athletic Trainer. "Board of Certification for the Athletic Trainer" means the national credentialing organization for the entry-level athletic training profession or its successor organization approved by the department.
16 17	Amend the bill in section 3 in subsection 1 in paragraph D in the last line (page 1, line 29 in L.D.) by striking out the following: "or successor organization"
18 19	Amend the bill in section 3 in subsection 1 in paragraph E in the first 2 lines (page 1, lines 30 and 31 in L.D.) by striking out the following: "or successor organization"
20 21	Amend the bill in section 4 in the indented paragraph in the last line (page 1, line 37 in L.D.) by striking out the following: "or successor organization"
22 23	Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
