12 13	'Resolve, to Establish the Committee to Study the Use of Sunflower Crops to Produce Biofuels and Other Products'
14	Amend the resolve by inserting after the title the following:
15 16	'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
17 18 19	Whereas, the Legislature finds it is important to explore the feasibility of new opportunities for agricultural producers in Maine, to enhance on-farm efficiencies and to expand new markets while contributing to the growth of rural economies in Maine; and
20 21	Whereas, this legislation establishes the Committee to Study the Use of Sunflower Crops to Produce Biofuels and Other Products; and
22 23 24 25	Whereas, this legislation needs to take effect before the expiration of the 90-day period to allow the Committee to Study the Use of Sunflower Crops to Produce Biofuels and Other Products to conduct its work as soon as possible so that it may report back to the Legislature by December 3, 2025; and
26 27 28 29	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it'
30 31	Amend the resolve in section 1 in the 2nd line (page 1, line 2 in L.D.) by inserting after the following: "Biofuels" the following: 'and Other Products'
32 33	Amend the resolve by striking out all of section 2 (page 1, lines 4 to 27 in L.D.) and inserting the following:



1 2	'Sec. 2. Committee membership. Resolved: That, notwithstanding Joint Rule 353, the committee consists of 9 members appointed as follows:
3 4 5 6	1. Two members of the Senate, appointed by the President of the Senate, including a member from each of the 2 parties holding the largest number of seats in the Legislature, one member who serves on the Joint Standing Committee on Energy, Utilities and Technology and one member who represents Aroostook County;
7 8 9	2. Two members of the House of Representatives, appointed by the Speaker of the House, one member who serves on the Joint Standing Committee on Agriculture, Conservation and Forestry and one member who represents Aroostook County;
10 11	3. One member who serves on the Maine Potato Board, appointed by the President of the Senate;
12 13	4. One member representing the Maine Energy Marketers Association, appointed by the President of the Senate;
14 15	5. One member representing the University of Maine at Presque Isle, appointed by the Speaker of the House; and
16 17	6. Two members representing renewable energy companies in the State, appointed by the Speaker of the House.'
18 19	Amend the resolve in section 5 in the 2nd line (page 1, line 39 in L.D.) by inserting after the following: "biofuels" the following: ', food-grade oil and livestock feed'
20	Amend the resolve by adding before the summary the following:
21 22	'Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'
23 24	Amend the resolve by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
25	SUMMARY
26 27 28 29 30 31	This amendment renames the study committee established in the resolve the Committee to Study the Use of Sunflower Crops to Produce Biofuels and Other Products. The amendment revises the membership of the committee. The amendment directs the committee to study the feasibility of using the State's sunflower crops to produce food- grade oil and livestock feed in addition to biofuels as proposed in the resolve. The amendment adds an emergency preamble and emergency clause to the resolve.

Legislative Cost/Study

The general operating expenses of this study are projected to be \$3,050 in fiscal year 2025-26. The Legislature's proposed budget for the 2026-2027 biennium includes \$22,196 in each of fiscal years 2025-26 and 2026-27 for the costs of legislative studies, as well as \$8,265 in projected balances from fiscal year 2024-25 and \$33,073 of balances carried over from prior years for this purpose. Whether these amounts are sufficient to fund all studies will depend on the number of studies authorized by the Legislative Council and the Legislature. The additional costs of providing staffing assistance to the study during the interim can be absorbed utilizing existing budgeted staff resources.

Fiscal Detail and Notes

Additional costs to the University of Maine System for a representative of the University of Maine at Presque Isle to serve on the committee can be absorbed within existing budgeted resources.
