1 Be it enacted by the People of the State of Maine as follows: 2 Sec. 1. 20-A MRSA §9924 is enacted to read: 3 §9924. Community Schools Success Fund 4 1. Fund established. The Community Schools Success Fund, referred to in this section as "the fund," is established within the department as a nonlapsing fund to provide grants 5 to community schools, local education providers and nonprofit organizations. The 6 commissioner shall administer the fund to provide community schools with assistance with 7 8 the following: 9 A. Community needs audits and community schools resources assessment; 10 B. Readiness plan assessments; 11 C. New and ongoing sustainability efforts; 12 D. Professional development and training; and 13 E. Peer support and mentoring efforts. 14 For the purposes of this section, "local education provider" means a school administrative 15 unit, a school located in an unorganized territory pursuant to chapter 119, a public charter school authorized pursuant to chapter 112 and a school or program established under Part 16 17 4, Subpart 2. 18 2. Grant recipients; supporting documentation. To receive a grant under this 19 section, a potential recipient must be designated as a community school pursuant to section 20 9922 or must be a local education provider located in a school administrative unit with a 21 community school or a nonprofit organization that supports community school programs. 22 A potential recipient shall submit to the department a grant utilization plan that includes 23 the scope of work that will be supported by the grant and a description of programs administered by the potential recipient that support community schools. 24 25 3. Rules. The commissioner shall adopt rules necessary to carry out the purposes of the 26 fund, including eligibility standards for the awarding of grants from the fund under this 27 section and rules for determining the allowable uses of grants by eligible recipients, which 28 must include, but are not limited to, hiring or contracting, technical assistance, professional 29 development and training and attending statewide training and conferences. Rules adopted 30 pursuant to this subsection are routine technical rules as defined in Title 5, chapter 375, 31 subchapter 2-A. **SUMMARY** 32 33 This bill establishes the Community Schools Success Fund, a nonlapsing fund within 34 the Department of Education, to provide grants to community schools, local education 35 providers and nonprofit organizations to support community school programs.
