SUMMARY

This amendment replaces the term "culvert upgrade" with "stream crossing" to specify that the program relates to a stream crossing replacement. The amendment updates the criteria for awarding grants. The Department of Transportation is required to consider the extent to which the project meets 1.2 times the stream's bankfull width standard and the stream crossing meets the department's flood standard, rather than the Department of Environmental Protection's design standard. The amendment also removes the requirement that the Department of Transportation adopt rules regarding the grant program and the Municipal Stream Crossing Fund.

Fiscal Detail and Notes

The bill establishes the Municipal Stream Crossing Fund within the Department of Transportation with base Other Special Revenue Funds allocations and Federal Expenditures Funds allocations of \$500 beginning in fiscal year 2025-26.

Any additional costs to the Department of Transportation associated with establishing and administering the competitive grant program are expected to be minor and can be absorbed within existing budgeted resources.
