1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 20-A MRSA §13011, sub-§6-C is enacted to read:
3	6-C. Additional pathways for industrial arts certification; conditional certificate;
4	endorsement. The state board shall adopt rules relating to the credentialing of educational
5	personnel to create a pathway for a teacher to obtain a conditional certificate and a pathway
6	for a teacher to obtain an endorsement on a teaching certificate for a component of
7	industrial arts as defined by the department with an experiential laboratory that includes,
8	but is not limited to, automotive body repair, diagnostics and mechanics; welding;
9	electrical; carpentry; and computer-aided design. An endorsement under this subsection
10 11	must be separate from other endorsements. At a minimum, rules adopted pursuant to this subsection to obtain a conditional certificate must include the following qualifications:
12 13	A. A completed apprenticeship registered with a statewide or national apprenticeship and training organization;
14 15	B. A completed 2-year degree or certificate from a technical institution accredited by a national association of career and technical schools or similar organization; and
16 17 18	C. Completion of a minimum of 36 months of paid work experience or teaching experience in a career and technical endorsement area, of which a minimum of 12 months was:
19	(1) At a supervisory level; and
20 21	(2) Completed during the 5 years immediately preceding application for a conditional certificate or endorsement under this subsection.
22 23	Rules adopted pursuant to this subsection are major substantive rules as defined in Title 5, chapter 375, subchapter 2-A.

25 26 27 28	This bill directs the State Board of Education to adopt rules to amend the credentialing of educational personnel to create a pathway for a teacher to obtain a conditional certificate and a pathway for a teacher to obtain an endorsement on a teaching certificate for a component of industrial arts with an experiential laboratory.
