1	Amend the resolve by striking out the title and substituting the following:

13	Amend the resolve by inserting after the title and before section 1 the following:
14 15	'Emergency preamble. Whereas, acts and resolves of the Legislature do no become effective until 90 days after adjournment unless enacted as emergencies; and
16 17 18	Whereas, this resolve establishes a working group to study and advise on the potential for innovative housing construction technologies to reduce housing production costs and accelerate housing production in the State; and
19 20 21	Whereas, the study must be initiated before the 90-day period expires so that the study may be completed and a report submitted in time for consideration during the next legislative session; and
22 23 24 25	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation a immediately necessary for the preservation of the public peace, health and safety; now therefore, be it'
26 27 28	Amend the resolve in section 1 in the first 2 lines (page 1, lines 1 and 2 in L.D.) by striking out the following: "Innovative Factory-made Housing" and inserting the following 'Housing Production Innovation'
29	Amend the resolve by striking out all of sections 2 and 3 and inserting the following:
30 31	'Sec. 2. Working group membership. Resolved: That, notwithstanding Join Rule 353, the working group consists of 11 members appointed as follows:

- 2. Two members of the House of Representatives, including one member from each of the 2 parties holding the largest number of seats in the Legislature and who serve on the Joint Standing Committee on Housing and Economic Development, appointed by the Speaker of the House;
- 3. The Commissioner of Professional and Financial Regulation or the commissioner's designee;
- 4. The Commissioner of Economic and Community Development or the commissioner's designee;
- 5. The Director of the Office of Policy Innovation and the Future or the director's designee;
- 6. The Director of the Maine Office of Community Affairs or the director's designee; and
- 7. Three members from the residential construction and building materials manufacturing industries, one appointed by the President of the Senate, one appointed by the Speaker of the House and one appointed by the Governor.'
- Sec. 3. Chairs. Resolved: That, notwithstanding Joint Rule 353, at the first meeting of the working group, the members shall elect, by majority vote of those present, 2 members appointed under section 2, subsections 3 to 7 as chairs of the working group.

Amend the resolve in section 4 in the first line (page 2, line 32 in L.D.) by inserting after the following: "That" the following: ', notwithstanding Joint Rule 353,'

Amend the resolve in section 4 in the 4th line (page 2, line 35 in L.D.) by inserting after the following: "Council" the following: 'and the Commissioner of Economic and Community Development'

Amend the resolve in section 4 in the 5th line (page 2, line 36 in L.D.) by striking out the following: "chairs" and inserting the following: 'Commissioner of Economic and Community Development'

Amend the resolve in section 4 in the next to the last line (page 2, line 38 in L.D.) by striking out the following: "chairs" and inserting the following: 'Commissioner of Economic and Community Development'

Amend the resolve by striking out all of section 5 and inserting the following:

- 'Sec. 5. Duties. Resolved: That the working group shall study the potential for innovative housing construction technologies to reduce housing production costs and accelerate housing production in the State. Innovative housing construction technologies may include modular housing, componentized housing, 3-dimensional printing or other approaches to residential construction. The working group shall consider regulatory and financial solutions to barriers to achieving this potential, including, at a minimum, the following:
- 1. Demand-side barriers that inhibit adoption of factory-made housing technologies, including:

1 2	A. A lack of familiarity and expertise among homebuilding professionals, developers and homeowners; and

5 6	2. Production-side barriers that inhibit the availability and cost competitiveness of factory-made housing technologies, including:
7	A. Varying building codes, inspection standards and approval processes;
8	B. Inconsistent licensing requirements for factory-made housing technologies;
9 10	C. A lack of workers in relevant fields trained in factory-made housing production and construction; and
11 12	D. Challenges with transporting and exporting prefabricated housing products made in the State.
13 14 15 16	In researching these topics and establishing recommendations, the working group shall consult with individuals active in the housing industry, including those representing manufacturers, builders, developers, trades, training providers, regulators and finance organizations and those engaging in research at institutions of higher education in the State.
17 18 19	Sec. 6. Staff assistance. Resolved: That, notwithstanding Joint Rule 353, the Department of Economic and Community Development shall provide necessary staffing services to the working group.'
20	Amend the resolve by adding before the summary the following:
21 22	'Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'
23 24	Amend the resolve by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
25	SUMMARY
26 27	This amendment changes the title of the resolve and the name of the working group and:
28 29	1. Reduces the number of members of the Housing Production Innovation Working Group from 36 to 11;
30	2. Redefines the duties of the working group;
31	3. Requires the working group to elect 2 chairs for the working group;
32 33	4. Requires the Department of Economic and Community Development to provide staff support to the working group; and
34	5. Adds an emergency preamble and emergency clause.

The general operating expenses of this study are projected to be \$2,800 in fiscal year 2025-26. The Legislature's proposed budget for the 2026-2027 biennium includes \$22,196 in each of fiscal years 2025-26 and 2026-27 for t costs of legislative studies, as well as \$8,265 in projected balances from fiscal year 2024-25 and \$33,073 of balances carried over from prior years for this purpose. Whether these amounts are sufficient to fund all studies will depend on the number of studies authorized by the Legislative Council and the Legislature.

Fiscal Detail and Notes

Additional costs to the Department of Economic and Community Development to staff the working group and the Governor's Office of Policy Innovation and the Future and the Maine Office of Community Affairs to serve on the working group established to conduct the required study and submit the required report can be absorbed within existing budgeted resources.
