The office shall reduce barriers to workforce participation in areas such as health care, housing, child care, direct care education and training and increase investment in workforce participation.

24 25 26 27	This bill creates the Office of Workforce Advancement within the Department of Economic and Community Development and directs the department to establish statewide workforce advancement goals in coordination with the Department of Labor and other stakeholders to grow the State's workforce and economy.
