### **An Act Regarding Cannabis Testing and the Manufacture of Cannabis and Hemp Products**

1       **Be it enacted by the People of the State of Maine as follows:**

2       **Sec. 1. 28-B MRSA §502, sub-§1-A**, as enacted by PL 2023, c. 679, Pt. B, §68, is  
3 amended to read:

4       **1-A. Manufacture of products not containing cannabis.** Notwithstanding  
5 subsection 1, a products manufacturing facility licensee that also has a license issued from  
6 the Department of Agriculture, Conservation and Forestry pursuant to subsection 10 may  
7 manufacture for sale or distribution any products that the facility is authorized to  
8 manufacture or distribute pursuant to the provisions of that license, including products that  
9 do not contain cannabis, ~~except that a products manufacturing facility licensee is prohibited~~  
10 ~~from extracting hemp as defined in Title 7, section 2231, subsection 1-A, paragraph D or~~  
11 ~~manufacturing products that contain hemp or ingredients derived from hemp that do not~~  
12 ~~also contain cannabis. Nothing in this~~ This subsection may not be construed to prohibit a  
13 products manufacturing facility licensee from using ingredients derived from hemp, as  
14 defined in Title 7, section 2231, subsection 1-A, paragraph D, in the manufacture of  
15 cannabis products or simultaneously using manufacturing-related equipment, supplies and  
16 facilities for the manufacturing of cannabis products and hemp products.

17       A. A products manufacturing facility licensee that manufactures adult use cannabis  
18 and adult use cannabis products within the same facility in which the licensee also  
19 manufactures products that do not contain cannabis must comply with all applicable  
20 requirements of this chapter and the rules adopted pursuant to this chapter concerning  
21 the operation of products manufacturing facilities.

22       B. The following items or areas within the facility may be shared for both the  
23 manufacturing of adult use cannabis and adult use cannabis products and the  
24 manufacturing of products that do not contain cannabis:

25           (1) Manufacturing-related and nonmanufacturing-related equipment and supplies,  
26 except that manufacturing-related equipment and supplies may not be  
27 simultaneously used for the manufacturing of adult use cannabis and adult use  
28 cannabis products and the manufacturing of products that do not contain cannabis;

29           (2) Manufacturing-related and nonmanufacturing-related supplies or products that  
30 do not contain cannabis or cannabis products and the storage areas for those  
31 supplies or products; and

32           (3) General office space, bathrooms, entryways and walkways.

33       C. A products manufacturing facility licensee must ensure that:

34           (1) Manufacturing-related equipment and supplies are not simultaneously used for  
35 the manufacturing of cannabis and cannabis products and the manufacturing of  
36 products that do not contain cannabis;

37           (2) Manufacturing-related equipment is sanitized between the manufacturing of  
38 cannabis and cannabis products and the manufacturing of products that do not  
39 contain cannabis;

40           (3) Cannabis and cannabis products are kept separate from products that do not  
41 contain cannabis;

1 (4) Cannabis and cannabis products are packaged and labeled accurately pursuant  
2 to the requirements of this chapter and the rules adopted pursuant to this chapter;

3 (5) Products that do not contain cannabis are packaged and labeled accurately  
4 pursuant to the provisions of the license issued by another department to  
5 manufacture products that do not contain cannabis; and

6 (6) Any person manufacturing products that do not contain cannabis in a licensed  
7 manufacturing facility obtains an individual identification card from the office  
8 pursuant to section 106, except that the person is not required to submit to a  
9 criminal history record check.

10 **Sec. 2. 28-B MRSA §605, sub-§4**, as amended by PL 2023, c. 679, Pt. B, §120, is  
11 further amended to read:

12 **4. No subsequent processing, manufacturing or alteration.** Since the performance  
13 of the prior testing under subsection 1, the cannabis or cannabis product has not undergone  
14 any further processing, manufacturing or alteration that would result in an increase in the  
15 concentration of any contaminants or factors identified in section 602, subsection 1 or in  
16 any rules adopted by the office pursuant to that section. For purposes of this subsection,  
17 further processing, manufacturing or alteration does not include the use of a cannabis  
18 extract or distillate in the creation of a baked good or other edible cannabis product, except  
19 for testing under section 602, subsection 1, paragraph F.

## 20 SUMMARY

21 This bill removes the prohibition of simultaneously using manufacturing-related  
22 equipment, supplies and facilities for the manufacturing of cannabis and cannabis products  
23 and the manufacturing of hemp products and clarifies that the further processing,  
24 manufacturing or alteration of cannabis or cannabis products does not include the use of a  
25 cannabis extract or distillate in the creation of a baked good or other edible cannabis  
26 product except for potency, homogeneity and cannabinoid profiles.
