The amendment also 26 amends the resolve by stating that the office must exclude from the study procurements 27 conducted by the Public Utilities Commission for energy or transmission infrastructure 28 pursuant to the Maine Revised Statutes, Title 35-A. 29 FISCAL NOTE REQUIRED
