determines consistent with this chapter or as otherwise provided by law or by the terms and conditions of any gift, grant, devise, bequest, trust or security document.'

Amend the bill in section 2 in the 4th and 5th lines (page 3, lines 14 and 15 in L.D.) by striking out the following: "Joint Standing Committee on Education" and inserting the following: 'joint standing committee of the Legislature having jurisdiction over education matters'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

This amendment provides that members of the Maine Green Schools Network may be invited by the Department of Education to participate in the network subject to available funding and requires the network to create a statewide community of practice among educators and administrators for the purpose of sharing curricula, instruction and assessment practices related to community resilience and changing ecosystems. The amendment also makes changes to the membership of the network and requires that any funds received by the department must be used in a manner consistent with the law governing the network as set out in the bill or as otherwise provided in law or the terms and conditions of the funds received.
