COMMITTEE AMENDMENT "A" to H.P. 1092, L.D. 1651, "An Act to Remove the Term "Alleged" When Referring to Victims of Sexual Assault in the Maine Revised Statutes"

Amend the bill by striking out the title and substituting the following:

'An Act to Remove the Term "Alleged" When Referring to Victims of Sexual Assault in the Provisions of the Maine Revised Statutes Pertaining to Forensic Examinations'

Amend the bill in section 7 in §287 in subsection 1 in the last line (page 4, line 28 in L.D.) by striking out the following: "victims" and inserting the following: 'victims a victim of the alleged crime'

Amend the bill in section 7 in §287 in subsection 2-A in the 3rd line (page 4, line 38 in L.D.) by inserting after the following: "victim" the following: 'of the alleged crime'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

This amendment makes a technical change to the bill to clarify that the evidence collected during a forensic examination relates to an alleged sexual assault crime.
