14 15 16	1. Appointment; composition. The Cannabis Advisory Council, referred to in this section as "the council" and established by Title 5, section 12004-I, subsection 2-J, consists of 10 members who are appointed as follows:		
17 18 19 20 21	A. Three members who are registrants under the Maine Medical Use of Cannabis Act, of which at least one member is a registered caregiver, appointed by the President of the Senate. In making the appointments under this paragraph, the President of the Senate shall consider up to 6 recommendations from associations representing the interests of the Maine Medical Use of Cannabis Act;		
22 23 24	B. One public member who is a qualifying patient under the Maine Medical Use of Cannabis Act with knowledge of and interest in the medical use of cannabis, appointed by the President of the Senate;

2. Purpose. The council shall make recommendations to the director and the joint standing committee of the Legislature having jurisdiction over cannabis matters concerning:

- A. How best to work with state agencies, municipal governments, the medical use cannabis industry and adult use cannabis industry and citizen groups to make improvements to and maintain the quality of the State's medical use cannabis industry and adult use cannabis industry; and
- B. Matters of interest to the State's medical use cannabis industry and adult use cannabis industry, including, but not limited to, changes to the tracking system contract, public health protection and federal legalization.

The council is responsible for bringing forward to the director and the joint standing committee of the Legislature having jurisdiction over cannabis matters issues of concern to the medical use cannabis industry and adult use cannabis industry and for assisting in the dissemination of information to members of the medical use cannabis industry and adult use cannabis industry.

- 3. Terms. The term of a member appointed to the council is 3 years, except that a vacancy during an unexpired term must be filled in the same manner as for the original member for the unexpired portion of the member's term. A member may not serve more than 2 consecutive terms.
- 4. Chair and vice-chair. The council shall elect a member of the council as chair and a member as vice-chair at the first regular meeting of each year. The term of the chair and vice-chair is one year.
- 5. Meeting. The council shall meet at least once a year. It may also meet at other times at the call of the chair or the director. In advance of a meeting with an organization holding the contract for the tracking system for cannabis with the State, the council shall meet to discuss matters of interest to the medical use cannabis industry and adult use cannabis industry, the department and the organization holding the contract for the tracking system for cannabis and to make recommendations to the director and the joint standing committee of the Legislature having jurisdiction over cannabis matters as necessary.
- 6. Compensation. Council members are entitled to reimbursement for expenses in accordance with Title 5, chapter 379, which is paid in equal proportions from the Adult Use Cannabis Regulatory Coordination Fund established in section 1102 and the Medical Use of Cannabis Fund established in Title 22, section 2430.
- **Sec. 4. 28-B MRSA §1102,** as amended by PL 2023, c. 679, Pt. B, §141, is further amended to read:

§1102. Adult Use Cannabis Regulatory Coordination Fund

The Adult Use Cannabis Regulatory Coordination Fund, referred to in this section as "the fund," is established as a dedicated, nonlapsing Other Special Revenue Funds account in the office. The fund is administered and used by the director for the purposes of adopting rules under this chapter and, for the purposes of implementing, administering and enforcing this chapter and for the purpose of paying the reimbursement for expenses of the Cannabis Advisory Council established by Title 5, section 12004-I, subsection 2-J. The director may expend money in the fund to enter into contracts with consultants and employ staff, as determined necessary by the director, conduct meetings with stakeholders and conduct any

other activities related to the implementation, administration and enforcement of this chapter.

The council is responsible for bringing forward to the director and the joint standing committee of the Legislature having jurisdiction over cannabis matters issues of concern to the medical use cannabis industry and adult use cannabis industry and for assisting in the dissemination of information to members of the medical use cannabis industry and adult use cannabis industry.
