#### **Fiscal Detail and Notes**

The bill includes General Fund appropriations to the Judicial Branch of \$207,695 in fiscal year 2025-26 and \$456,162 in fiscal year 2026-27 to establish 5 assistant clerk positions, effective February 1, 2026, to implement the process of appointing defense counsel within 24 hours for an incarcerated accused person who is indigent.
