Resolve, to Establish a Pilot Program to Protect Firefighters from Cancer

- **Sec. 1. Pilot program established. Resolved:** That the Commissioner of Public Safety shall establish the firefighter early detection cancer screening pilot program.
- 1. All active and retired firefighters must be offered a comprehensive early detection cancer screening that consists of any combination of one or more of the following tests: a blood test, an ultrasound of vital organs and a computed tomography, or CT, scan of the lungs. As used in this resolve, "firefighter" means a municipal firefighter or volunteer firefighter, as defined in the Maine Revised Statutes, Title 30-A, section 3151, subsections 2 and 4, respectively.
 - 2. Vendors with the ability to conduct the following tests must be preferred:
 - A. A multi-cancer blood test that detects signals from as many cancer types as possible, including those that are commonly unscreened; and
 - B. An echocardiogram, a carotid doppler and an ultrasound diagnostic that screens, at minimum, abdominal aorta, thyroid, liver, gallbladder, spleen, bladder, kidney, prostate, testicles and exterior pelvis for females.
- **Sec. 2. Committee. Resolved:** That, within 90 days of the effective date of this resolve, a committee consisting of representatives from an association of professional firefighters, an association of fire chiefs and the Department of Public Safety, with oversight from the Commissioner of Public Safety or the commissioner's designee, shall present to the commissioner and the Governor the committee's initial plan to administer the pilot program, which must consist of:
 - 1. Known vendors who can provide appropriate screenings;
- 2. Location and time to provide screenings; and
- 3. Administrative requirements to:
- A. Notify firefighters of the pilot program;
- B. Register and screen firefighters;
- C. Document findings; and

- D. Provide ongoing recommendations to the Legislature.
 - **Sec. 3. Participation optional. Resolved:** That firefighter participation in cancer screenings is optional and a firefighter is eligible to receive any combination of offered screenings.
 - **Sec. 4. Term. Resolved:** That the term of the pilot program must be not more than 24 months from the date of a plan approval by the Governor and the Commissioner of Public Safety, unless the Governor grants a request for an extension.
 - **Sec. 5. Self-funded screenings. Resolved:** That an active or retired firefighter who self-funds any portion of the screenings provided by the pilot program after January 1, 2025 may submit for reimbursement of such costs, not to exceed \$1,300 from the pilot program. The firefighter must submit required documentation for reimbursement.
 - **Sec. 6. Committee findings. Resolved:** That the committee under section 2 shall present the committee's findings to the Governor and the joint standing committee of the Legislature having jurisdiction over public safety matters after 12 months and again after

24 months of the pilot program's administration. These findings must include the number of firefighters screened; tests conducted; results of tests; follow-up testing to confirm the results of the screening; costs of follow-up tests and method of payment, including the firefighters' share of the costs; and any recommendations for the pilot program. All providers of services shall ensure the name and any other personally identifiable information of the individual is removed prior to providing results to the committee.

7 SUMMARY

This resolve requires the Commissioner of Public Safety to establish the firefighter early detection cancer screening pilot program.
