17	group to study the feasibility of establishing the crime of racketeering for drug offenses and					
18	sex trafficking. The office is required to submit a report by January 1, 2026 to the Joint					
19	Standing Committee on Criminal Justice and Public Safety, which may submit legislation					
20	to the Second Regular Session of the 132nd Legislature. The amendment removes the					
21	emergency preamble and clause. The amendment also adds an appropriations and					
22	allocations section.
