HOUSE AMENDMENT " U " to COMMITTEE AMENDMENT "A" to H.P. 1491, L.D. 2212, "An Act Making Supplemental Appropriations and Allocations from the General Fund and Other Funds for the Expenditures of State Government and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2026 and June 30, 2027"

Amend the amendment by inserting after Part HHHH the following:

'PART III

Sec. III-1. Department of Health and Human Services to reimburse hospitals after receipt of cost reports. The Department of Health and Human Services shall amend its rules in Chapter 101: MaineCare Benefits Manual, Chapter III, Section 45, Hospital Services, to require the department to reimburse 75% of the as-filed settlement pursuant to a hospital's cost reports within 90 days of receipt and to provide that the remaining 25% is paid incrementally after the audits are finished.

Sec. III-2. Existing resources. The Department of Health and Human Services shall implement the requirements of this Part within existing resources.

Sec. III-3. Appropriations and allocations. The following appropriations and allocations are made.

Department of Health and Human Services Central Operations 0142

Initiative: Provides funding to establish one Staff Auditor II position to review and verify hospital cost reports and prepare payments for settlement. The initiative also provides funding for related All Other costs.
