# IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE.

AN ACT to incorporate the town of Old Orchard.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. All that part of the city of Saco 2 lying within the following described lines and 3 boundaries, namely, commencing at the easterly 4 corner, between the said city of Saco and the town 5 of Scarboro', at low water mark, thence by the line 6 between said city of Saco and said town of Scar-7 boro', northwesterly to a stone in the sea wall, 8 thence north forty-two degrees and fifty-five min-9 utes west, by said line, six hundred and ninety-10 three rods to a granite stone placed at a point 11 where the line between said city of Saco and said 12 town of Scarboro' intersects with a line in said 13 city of Saco known as the Granger line, thence 14 south forty-seven degrees and twelve minutes west, 15 eight hundred and sixty-three and one half rods to 16 a granite stone on the bank of Goose Fair brook, 17 in said city of Saco, thence southeasterly by said 18 Goose Fair brook to the sea, thence by the sea to 19 the boundary first above named, with all the sea 20 shore and flats lying between said Goose Fair 21 brook and said easterly corner of the city of Saco, 22 is hereby incorporated into a separate town by the 23 name of Old Orchard; and the inhabitants thereof 24 are hereby invested with all the powers and privi-25 leges, and are made subject to all the duties and 26 liabilities incident to other towns within this state.

SECT. 2. All taxes heretofore legally assessed 2 upon property within the said limits of Old 3 Orchard shall remain valid and shall be collected 4 from the persons or corporations, against whom 5 they are assessed, by the collector of the city of 6 Saco, to whom they have been or may be com-7 mitted, and shall be applied to the several purposes 8 for which they are raised. All existing provisions 9 of law shall be applicable to said taxes and their 10 collection, and all existing liens shall be preserved. SECT. 3. Said town of Old Orchard shall have 2 power to raise money and expend the same, to 3 provide and maintain a police force, to purchase 4 and maintain engine houses, reservoirs, engines 5 and other apparatus for the extinguishment of 6 fires, and to organize and equip fire companies in 7 connection therewith, to establish and maintain 8 drains and sewers and other proper means for the 9 preservation of the public health, and to build and 10 repair sidewalks; and for the purposes of such 11 improvements said town shall have power to take • 12 private property, and the damages to be paid 13 therefor shall be determined in the same manner 14 as now provided by statute in the case of town 15 ways.

SECT. 4. All monies raised by said town for the 2 purposes named in the preceding section, and to be 3 applied for the making of said improvements with-4 in the following described limits in the town of Old 5 Orchard, namely, commencing at a point at low 6 water mark on Old Orchard beach, on the division 7 line between the town of Scarboro' and city of 8 Saco, thence north forty-two degrees and fifty-five 9 minutes west by said division line to a stake at 10 mean high water mark placed one hundred and

11 ninety-two feet south easterly from the stone mon-12 ument placed by the municipal officers in said line, 13 thence from said stake north forty-two degrees and 14 fifty-five minutes west on said division line, thirteen 15 hundred and eighty-four feet to an iron monument 16 upon the north westerly property line of the Boston 17 and Maine railroad, thence south forty-five degrees 18 west by said property line fifty-five hundred and 19 eighty-eight feet to an iron monument, thence 20 north forty-five degrees west, forty-four hundred 21 and eighty-three feet to an iron monument, thence 22 south forty-five degrees west sixty-three hundred 23 feet to an iron monument and post, upon the west-24 erly side of Union avenue so called, standing at the 25 northerly corner of the homestead farm of John 26 Jameson, thence south thirty-six degrees west, on 27 the line known as the first division line of John 28 Bony, thence seventy-six hundred and forty-four feet 29 to an iron monument in the ditch bank at the edge 30 of the salt marsh bordering on Goose Fair brook, 31 thence on the same course to the center of Goose 32 Fair brook, thence south easterly by said brook to 33 low water mark on Old Orchard beach, thence 34 north easterly by the low water line of said beach 35 to the point of beginning, shall form separate taxes,

36 and shall be assessed upon the polls and estates37 within said limits, within which such money is to38 be expended.

SECT. 5. Whenever public drains or sewers 2 shall be constructed within the limits named in 3 section four of this act, it shall be the duty of the 4 assessors after notice to the abutters thereon and 5 hearing as provided by law in case of laying out 6 of town ways, to determine whether it is reason-7 able and proper that any such abutter upon whose 8 land any building shall have been erected shall en-9 ter such drain or sewer, and if in their judgment 10 it shall be reasonable and proper for such abutter 11 to enter his waste pipes or drains into such public 12 drain or sewer, they shall determine the amount to 13 be paid by him for the right so to do. They shall 14 also determine the amount to be paid by any abut-15 ter, owning vacant land upon the line of said 16 drain or sewer if in their opinion the same will be 17 benefitted thereby. Any person aggrieved by any 18 decision of such assessors may appeal to the 19 county commissioners for the county of York 20 within thirty days after he has been notified in 21 writing thereof, by said assessors. Said appeal shall 22 be in writing, and after notice stating the time and 23 place of the hearing thereof served upon said as-24 sessors at least seven days before the time fixed 25 therefor, said commissioners shall proceed to hear 26 the parties and their witnesses and determine said 27 appeal. When the amount of such damages shall 28 be finally determined, it shall be a lien upon the 29 premises upon which it was assessed, and may be 30 enforced by said town of Old Orchard in an action 31. of debt, if the same is not paid within thirty days 32 after such final determination. No abutter shall 33 enter such public drain or sewer until the amount 34 to be paid by him therefor shall have been so fixed 35 and paid.

SECT. 6. The inhabitants of said city of Saco 2 and said town of Old Orchard respectively, shall 3 own and hold all school houses, town farm, halls, 4 and other public property situated within their 5 several limits after this act shall take effect. And 6 the inhabitants of said town of Old Orchard shall 7 assume and pay all existing and outstanding lia-8 bilities incurred for the erection of the school 9 house at said Old Orchard, including a note of one 10 thousand dollars dated January twenty-first, 11 eighteen hundred and eighty-one, signed by Henry 12 W. Staples and F. J. Cousens, committee, payable 13 to John C. Bradbury, treasurer, and all other 14 notes issued by said committee by virtue of the 15 authority conferred on them by the city council of 16 the city of Saco June seventh, eighteen hundred 17 and eighty, and said inhabitants of the city re-18 maining after this act shall take effect shall assume 19 and pay all legal debts and liabilities now or here-20 after outstanding against said city of Saco. Said 21 town of Old Orchard or any inhabitant may re-22 cover of said city of Saco any money which he 23 shall be compelled to pay by reason of said debts 24 and liabilities, other than the taxes now legally as-25 sessed as aforesaid and said school-house liabili-26 ties.

SECT. 7. No person residing within said town 2 of Old Orchard at the time when this act shall 3 take effect, shall hereafter become chargeable as a 4 pauper or otherwise to said city of Saco unless 5 such person shall hereafter acquire a settlement 6 therein in some of the modes now provided by 7 law.

SECT. 8. The first meeting of the town of Old 2 Orchard may be called at Old Orchard by any 3 justice of the peace, by posting his warrant there-4 for, stating the time, place and purposes of said 5 meeting, in three public and conspicuous places
6 within said town, seven days at least before said
7 meeting. All officers chosen at said meeting shall
8 have all the powers of like officers as now provided
9 by law.

SECT. 9. The number of polls set to the city of 2 Saco shall be one thousand four hundred and 3 thirty-three, the value of estates three million 4 fifteen thousand three hundred and thirty-three 5 dollars; and the number of polls set to the town of 6 Old Orchard shall be one hundred and twenty-five, 7 and the value of estates three hundred and ninety-8 three thousand two hundred dollars; and all state 9 and county taxes hereafter shall be assessed ac-10 cordingly.

SECT. 10. This act shall take effect when ap-2 proved
