STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE.

AN ACT amendatory of chapter seventy-eight of the revised statutes, relating to courts and travel of county commissioners of Cumberland county.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Section six of chapter seventy-eight

- 2 of the revised statutes is hereby amended by in-
- 3 serting after the word "Cumberland" in the seventh-
- 4 line the words "terms of record" and by adding
- 5 after the word "June" in the eighth line, the words
- 6 "and regular sessions on the first Tuesday of each
- 7 month," so that the seventh and eight lines of said
- 8 section six as amended, shall read as follows: "In
- 9 the county of Cumberland, terms of record, on the

- 10 first Tuesdays of January and June; and regular
- 11 sessions on the first Tuesday of each month."
 - Sect. 2. Section nineteen of chapter seventy-
 - 2 eight aforesaid is hereby amended by inserting
 - 3 after the word "clerk" in the eighth line, the words
 - 4 "except in Cumberland county," so that said sec-
 - 5 tion as amended shall read as follows:
 - 6 Sect. 19. Each shall keep an accurate account
 - 7 of his time and travel, specifying the kind of ser-
 - 8 vice performed each day or part of a day, and the
 - 9 places from and to which he travelled each day, and
- 10 he shall not be allowed for services not so specified.
- 11 His account shall be audited and examined by the
- 12 county attorney and clerk, to the truth of which he
- 13 shall be sworn before one of them; and they shall
- 14 certify the amount allowed, and no further sum shall
- 15 be paid. The clerk, except in Cumberland county,
- 16 shall cause a copy of such account to be published
- 17 in the newspaper printed in the county, if any, and
- 18 return such printed copy to the secretary of state
- 19 by the first day of January in each year.
