#### STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE.

AN ACT relating to fines and penalties recovered for violation of the fish and game laws.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. All fines and penalties hereafter

- 2 recovered for the violation of chapters fifty and
- 3 seventy-five of the public laws of eighteen hundred
- 4 and seventy-eight and all acts amendatory thereof
- 5 and of all laws now in force in this state for the
- 6 protection of fish and game, shall be paid one-half
- 7 to the complainant and one-half to any game and
- 8 fish protective society or other sportmen's associa-
- 9 tion which shall have been organized under the
- 10 laws of Maine, and which may be located in the

11 county where the said fines and penalties are re-12 covered; provided, the said society or association 13 shall expend the same in the propagation and 14 cultivation of trout and salmon for the fresh water 15 lakes and ponds of Maine, to be done under the 16 direction and supervision of the fish commissioners. 17 In case there may be more than one such society 18 or association located in the county where said 19 fines and penalties are recovered, the fish commis-20 sioners shall designate which society the money 21 shall be paid to, or they may cause the same to be 22 divided between them. If there is no such society 23 or association in the county where such fines and 24 penalties are recovered, the fish commissioners 25 shall appropriate the same to such society as 26 aforesaid as they may deem proper.

- SECT. 2. All acts or parts of acts inconsistent 2 with this act are hereby repealed.
- Sect. 3. This act shall take effect when approved.

#### Amendment "A" to Senate Document No. 20.

Amend section one by striking out the words, 2 "the fish commissioners" in the 24th line and in-3 serting the following, viz: "then such fines and 4 penalties shall be paid to the state fish commissioners who" and by striking out in the 25th and 6 26 lines, the words "the same to such society as 7 aforesaid;" so that as amended the concluding 8 sentence in said section, (22d line) shall read as 9 follows:

- 10 "If there is no such society or association in the
- 11 county where such fines and penalties are recovered,
- 12 then such fines and penalties shall be paid to the
- 13 state fish commissioners who shall appropriate the
- 14 same as they may deem proper."
