## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-THREE.

AN ACT for the protection of salmon, land-locked salmon and trout.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. No person shall fish for, take, catch,

- 2 kill or destroy any fish in any waters, except tide
- 3 waters, with any net, seine, weir or trap, under a
- 4 penalty of fifty dollars for the offence and ten dol-
- 5 lars for each salmon or land-locked salmon, and
- 6 one dollar for each and every other fish so taken,
- 7 caught, killed or destroyed.

SECT. 2. No person shall kill or destroy any

- 2 land-locked salmon less than nine inches in length,
- 3 or any trout less than five inches in length, under

4 a penalty of five dollars for the offence and fifty 5 cents for each and every land-locked salmon or 6 trout so killed or destroyed. Any person having 7 in possession any land-locked salmon or trout of 8 less than the above dimensions shall be deemed to 9 have killed or destroyed them in violation of the 10 provisions of this section.

Sect. 3. No person shall take, catch, kill or have 2 in possession at any one time for the purpose of 3 transportation more than fifty pounds in weight 4 of land-locked salmon or trout, or of both to-5 gether, nor shall any such be transported except 6 in the possession of the owner thereof, under a 7 penalty of fifty dollars for the offence and five 8 dollars for each and every pound of land-locked 9 salmon or trout, or both together, so taken, caught, 10 killed, in possession or being transported in excess 11 of fifty pounds in weight; and all such fish trans-12 ported in violation of the provisions of this section 13 shall be liable to seizure, on complaint, and shall 14 be decreed by the court forfeited to the use of the 15 party prosecuting. Any person having in pos-16 session more than fifty pounds in weight of the 17 fish aforesaid, shall be deemed to have taken them 18 in violation of this section.

- Sect. 4. All penalties imposed by any of the 2 sections of this act may be recovered in the man-
- 3 ner provided by section twenty-six, chapter seventy-
- 4 five of the public laws of 1878.
