STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-FIVE.

AN ACT to amend chapter five hundred and fortyone of the Private Laws of eighteen hundred and
seventy-one, entitled "An Act to incorporate the
Penobscot and Lake Megantic Railroad Company"
as amend by chapter sixty-five of the Private Laws
of eighteen hundred and eighty-one.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section two of chapter five hundred 2 and forty-one, of the private laws of eighteen 3 hundred and seventy-one, as amended by section 4 one of chapter sixty-five of the private laws of 5 eighteen hundred and eighty-one, is hereby amended

6 by inserting after the word "lake" in the twen7 tieth line, the words, 'or from said European and
8 North American Railway, within the limits afore9 said to the east shore of Moosehead Lake, south
10 of Lily Bay, thence across said lake over Sugar
11 Island and Deer Island to the west shore of said
12 lake south of its outlet into Kennebec river, pro13 vided, that in crossing said lake, the bridges shall
14 be constructed to the approval of the railroad
15 commissioners of this State, and with whatever
16 draws said commissioners shall direct'; and by
17 inserting after the word "Greenville," in the
18 twenty-first line, the words, 'or the west shore of
19 Moosehead lake,' so that said section as amended
20 shall read as follows:

'Sect. 2. The said corporation is hereby fully em22 powered to survey, locate, construct, complete, alter,
23 equip and keep in repair, a railroad with one or more
24 tracks, and all necessary buildings, tunnels, via25 ducts, turnouts, side tracks, culverts, bridges,
26 drains, and all other needful appendages and ap27 purtenances, from some point on the line of the
28 European and North American Railway, between
29 the Passadumkeag and Mattawamkeag rivers, to
30 the Bangor and Piscataquis Railroad in the towns
31 of Orneville or Milo, and there connect with the

32 last named railroad, and thence from some point 33 on the Bangor and Piscataquis Railroad, between 34 its present terminus in the town of Foxcroft or 35 Abbot, when finished to Abbot and Moosehead 36 Lake; or from some point on the line of the 37 European and North American Railway, between 38 the south line of the town of Lincoln and the 39 north line of the town of Mattawamkeag, to 40 Greenville, near the foot of Moosehead Lake, on 41 a line which shall not be at any point within fifteen 42 miles of the Bangor and Piscataguis Railroad, 43 except where it shall approach and cross the line 44 of said last named railroad, near the foot of Moose-45 head Lake; or from said European and North 46 American Railway, within the limits aforesaid to 47 the east shore of Moosehead Lake, south of Lily 48 Bay, thence across said lake, over Sugar Island 49 and Deer Island, to the west shore of said lake, 50 south of its outlet into Kennebec River, provided, 51 that in crossing said lake, the bridges and ap-52 proaches thereto shall be constructed to the 53 approval of the railroad commissioners of this 54 State, and with said draws and spans as said com-55 missioners shall direct; and from Greenville, or 56 the west shore of Moosehead Lake, to some point 57 on the west line of the State between township

- 58 numbered three, in the fifth range of townships, 59 and the north branch of Moose River, and there 60 connect with the International Railroad, or any 61 other railroad which may be constructed from 62 Lenoxville, in the province of Quebec, eastwardly 63 to said State line.'
 - SECT. 2. Said corporation shall have until the 2 first day of January, eighteen hundred and eighty-3 six, to file with the county commissioners of the 4 several counties through which it shall pass, the 5 location of its line according to actual survey, 6 from the Kennebec River east to its junction with 7 the European and North American Railway.
 - Sect. 3. This act shall take effect when ap-2 proved.
