# STATE OF MAINE.

RESOLVE laying a tax on the counties of the State for the years eighteen hundred and eighty-five and eighteen hundred and eighty-six.

Resolved, That the sums annexed to the counties 2 in the following schedule are hereby granted as a 3 tax on each county respectively, to be appropriated, 4 assessed, collected and applied for the purpose of 5 paying the debts and necessary expenses of the 6 same, and other purposes ordered by law, for the 7 year one thousand eight hundred and eighty-five, 8 to wit: Androscoggin, twenty-eight thousand dol-9 lars; Aroostook, sixteen thousand dollars; Cum-10 berland, thirty thousand dollars; Franklin, seven 11 thousand dollars; Hancock, eleven thousand one 12 hundred and fifty dollars; Knox, twenty-one 13 thousand dollars; Kennebec, thirty-two thousand

14 dollars; Lincoln, eight thousand five hundred 15 dollars; Oxford, eleven thousand dollars; Penob-16 scot, thirty-two thousand dollars; Piscataquis, 17 ten thousand five hundred dollars; Sagadahoc, 18 fifteen thousand dollars; Somerset, fourteen thou-19 sand dollars; Washington, thirteen thousand dol-20 lars; Waldo, seventeen thousand dollars; York 21 twenty-two thousand five hundred dollars. For 22 the year one thousand eight hundred and eighty-23 six the following sums, to wit: Androscoggin, 24 twenty-eight thousand dollars; Aroostook, sixteen 25 thousand dollars; Cumberland, thirty thousand 26 dollars; Franklin, seven thousand dollars; Han-27 cock, eleven thousand one hundred and fifty dollars; 28 Knox, twenty-one thousand dollars; Kennebec, 29 thirty-two thousand dollars; Lincoln, eight thou-30 sand one hundred dollars; Oxford, ten thousand 31 two hundred dollars; Penobscot, thirty-two thou-32 sand dollars; Piscataquis, ten thousand five hun-33 dred dollars; Sagadahoc, fifteen thousand dollars; 34 dollars; Somerset, fourteen thousand dollars; 35 Washington, thirteen thousand dollars; Waldo, 36 seventeen thousand dollars; York, twenty-two 37 thousand five hundred dollars.
